BOARD OF STUDIES – DEPARTMENTAL BOARD

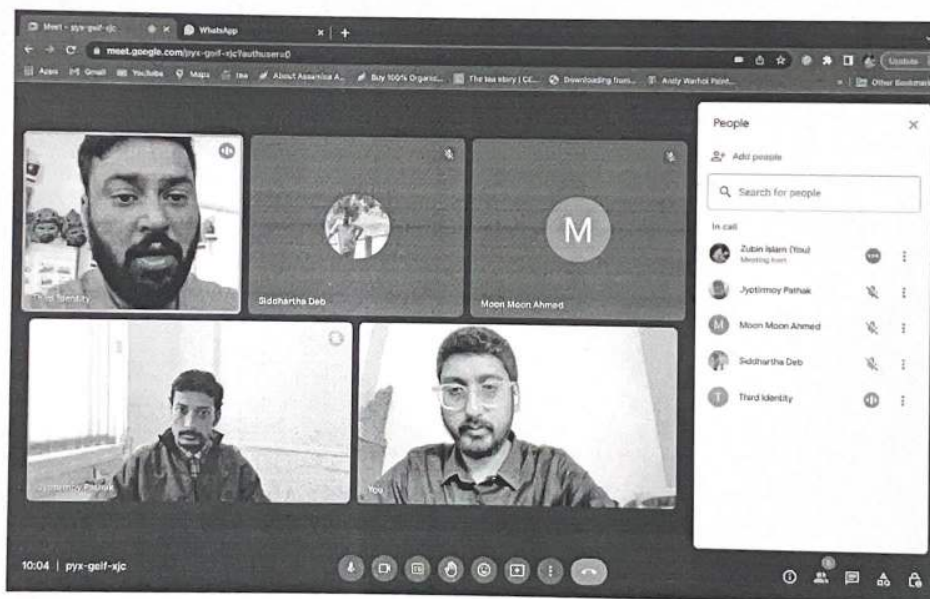
1. Welcoming the experts, HOD and Registrar Nominee to the meeting.
2. A clarification was needed as a point was put forth by the Dean of Academics that the credit system 2-0-4-4 will need theory evaluation as well as evaluation in practical based systems. On bringing up the topic in the meeting with the experts, the academic expert mentioned that design as a course needs to be evaluated in a practical manner and all subjects of design in NIFT is evaluated as practical subjects with external jury members. Hence, the possibility of changing the credit breakdown to 0-0-8-4 has been noted.
3. The importance of practical knowledge was put forth and all subjects should follow evaluation criteria with practical based outcomes.
4. Industry expert suggested the syllabus is already structured keeping in mind the courses are at industry standards with importance of practical knowledge.
5. The course and syllabus has also been ratified in accordance to NEP keeping in mind that a student can leave the course after any academic year with the needed skill set to be employable.
6. A suggestion to shift the subject "Publication Design" from the 5th semester to the 4th semester or make it the first subject to start from the 5th semester.
7. All major assignments in the 6th and 7th semester in subjects like Design Management and Design Entrepreneurship should be group based assignments. As training has to happen for students to learn and work in teams and know how to collaborate with other students working with their strengths and weaknesses.
8. Assessment of group assignments need to be critical of the students working in a team with their respective role in the group.

Observation on the Minute of the Board of Studies of the Royal School of Design held on 9th June 2022.

- A. Is this Minute of the 3rd Board of Studies meeting? It is not mentioned anywhere in the Minute. However, I assumed it to be the 3rd meeting based on content in point No. 3, where it is mentioned that *The following actions which were taken after the 2nd BoS, with respect to corrections-*
- B. In the Word document provided through the mail, it is mentioned in the Facing page

Syllabus and Course Structure
Bachelor in Design (Communication Design)

On the next page (Page 2), it is mentioned

Bachelor in Product Design

Also on the succeeding page (Page 3), it is mentioned

Bachelor in Product Design
Course Structure

Should it be a Bachelor of Communication Design? If so, it is to be corrected. Confusion arises because the course structure includes a course Introduction to Workshop which is normally a Product Design core course.

In case of any corrections are required on these 2 Pages, changing Bachelor of Product Design to Bachelor of Communication Design should be done.

Under point 3 a. of the BoS minute, it is mentioned that the name 'Colour and Form Studies' has been changed to 'Colour Theory'

-and in the word document provided through the email - at Level: Semester 1, a course: COD082C113 with Title of the Paper: '**Colour Theory**' is found and its contents are found to be appropriate. One conflict in the content is that in the 2nd-course objective it is mentioned that '*The emphasis is not on the psychological impact of colour, but learning the basic theory, through practical assignments*', but in the course outline, under unit 4, it is mentioned '*colour Psychology*'. This is self-contradictory. Colour theory is all about the formation of colour and consist of Pigment theory and light theory but designer must know the psychological impact

of using colour and hence 2nd course objective need modification. Otherwise, the changes have been appropriately implemented.

Under point 3 b. of the BoS minute, it is mentioned that the Subject and course '*Elements of Graphic Design*' has been removed and replaced with *Advanced Art History*.

-and in the word document provided through the email, there is no course named *Advanced Art History* at either Level: Semester 1 or 2, mentioned in the course structure or in the detailed syllabus in the document. Hence, this could not be verified.

Under point 3 c. of the BoS minute, it is mentioned that the Subject and course '*Design in Digital Media Platforms*' has been changed to '*New Media Design*'.

-and in the word document provided through the email, there is no course named '*New Media Design*' at either Level: Semester 1 or 2, mentioned in the course structure or in the detailed course in the document. Hence, this could not be verified.

Under point 3 d. of the BoS minute, it is mentioned that the course '*Socio Cultural Design*' has been moved to semester 3 from semester 2 and increased the credits from 2 to 3.
-and in the word document provided through the email, the course structure and syllabus beyond 2nd semester is not available. Hence, this could not be verified.

Under point 3 e. of the BoS minute, it is mentioned that the course '*Illustration Techniques and Exploration*' have been moved to 2nd semester from 3rd semester and lowered the credits from 3 to 2.

-and in the word document provided through the email – at Level: Semester 2, a course: COD082V215 with the title of the Paper: '*Illustration Techniques & Exploration*' is found and its contents are found to be appropriate. However, there are no reference materials mentioned in the Reference. This is essential and should be ensured.

Under point 3 f. of the BoS minute, it is mentioned that the nomenclature (or course Code) of '*Art of Research*' has been changed from COD082C205 to COD082C215
-and in the word document provided through the email, the course structure and syllabus beyond the 2nd semester is not available, and neither this course is mentioned in the document provided. Hence, this could not be verified.

Under point 4 of the BoS minute, it is mentioned that '*Further discussions and ratifications of syllabus was done with respect to the NEP laws and inclusion of industry experience, multiple exit system and holistic course structure*', but there is no details on this in the minute. Hence, this could not be verified.

Additional observation

1. For the Course: COD082C101, Introduction to Design, there are no reference materials mentioned in the Reference. This is essential and should be ensured.
