Paper 4: Plays and Playwrights I: The suggested texts have been added with Unit one on the History of English Drama from Medieval to the Renaissance.
- 2. InSemester II, Paper 2-In Literary Genre: Essay: "Essay as a Genre" added as Heading in Unit I; Montaigne and Bacon added; Hind Swaraj added. Paper 3- The Art of Fiction: Jonathan Swift's Gulliver's Travels removed.

Some specific suggestions in the Syllabi are, as listed below:

#### M.A. 1st semester

#### Paper I: English Literary and Cultural History

AC Bradley and David Daiches' books to be removed from 'References'. Instead, The Routledge History of Literature in English: Britain and Ireland is to be added.

#### M.A. Paper II: English Poetry (Chaucer to Pope)

J. A. Cuddon's Literary Terms to be added for reference and Alex Preminger and Hammond to be removed from syllabus. It was also suggested that Cuddon, also to be included in the library requisition. The remaining portions were approved by the board.

#### M.A. Paper III: English Drama

In the reference, Nicoll and Deiter's latest edition books are suggested to b e used. The rest is approved.

#### M.A. Paper IV: Non-Fiction Prose (the name of the course is to be Non-Fiction Prose rather than Non-Fictional Prose and Essays)

Content is approved. The suggestions were to incorporate group activity to develop writing skills and teachers to focus more as a guide rather than lecture. The Board also recommended that the course is to be divided among faculty and each group should produce assignments which could be a part of evaluation and oral presentation.

It was proposed that the course should be made more interdisciplinary. M. K. Naik's prescribed text should be updated to the latest/new edition, and also his poetry to be added.

Some specific suggestions regarding the Syllabi are, as listed below:

#### MA 2<sup>nd</sup> semester

Paper 2 English Poetry: The Prelude should be replaced by "Tintern Abbey."

#### BA 5th semester

Paper 1 American Literature: Two poems by each prescribed poet need to be included also, "Selections" should be mentioned against Walt Whitman's "Leaves of Grass".

Paper 3 African Literature: At least two poems of each prescribed poet should be included.

Paper DSE 5.1 Literature and Film: The Word and the Image: 'Introduction' should be included. Also the following texts need to be added in the references section: Linda Hutcheon's A Theory of Adaptation and McFarlane's Novel to Film: An Introduction to the Theory of Adaptation.

Paper DSE 5.2 Language and Linguistics: Yule's *The Study of Language* should be mentioned in "Texts" section, not "references".

Paper DSE 5.3 Modern American Literature: The Great Gatsby should be kept as "text in context".

#### BA 6th Semester

Paper 1 Texts and Contexts: Rewrite 'course objectives', insert the word "Literature" after each module name. Another poem by Jacky Kay should be included, as also a text by Patrick White.

Paper 2 Life Narratives- The Autobiography: "Selections" to be written after Istanbul.

Paper 3 Aesthetics of Representation: Prof. Madan Mohan will suggest a book to be added to References.

Paper DSE 6.1 New Literatures in English: More poems should be added, Vijay Tendulkar should be removed, and if possible, another dramatist's work should be included.

Paper DSE 6.2 Language and Linguistics: This paper, along with the 5<sup>th</sup> sem paper, should be reworked and made simpler.

#### NEP 2020 Requirement:

The members also discussed on the course to be offered with the implementation of NEP 2020. In the event of 4 years BA course becoming a reality, keeping in mind the new NEP 2020 framework, wherein 1 year of study will earn students a Certificate Degree; 2 years a Diploma Degree, 3 years, a Graduate Degree; and the 4 years, a Research Degree, a tentative syllabus for 1 year BA Certificate course was prepared by Dr Baishalee Rajkhowa, Coordinator RSL, and it was placed in front of the experts. A lot of issues pertaining to the same were raised during the discussion, and it was decided that the experts would take some time to go through the details of the said courses and the syllabus planned.

Prof. Liza Das also suggested courses to be provided in Liberal Arts.

- a. GE Syllabus: Since the GE Course is offered to the students of departments, other than the English Department, a detailed review of the course was made since the existing course seemed to be quite heavy for the students of other departments. Instead, a few modifications were suggested by the external members.
- b. GE 1st semester: The course has been considered okay for the students.
- c. GE 2<sup>nd</sup> semester: The following suggestions were made:

Unit I. The short story The Chrysanthemums to be removed.

Popular essays on science can be introduced.
