MINUITES OF THE FIRST BOS MEEETING

1.1 Dr. H.C Nath, Chairperson BOS, extended greetings to the members of the Board. He expressed his delightness to Dr. Aparajita Baruah (external Expert) who accepted to be a part of the Board of studies -I, to finalize and streamline various aspects connected to the BA.LLB (H) and LLM 1 year courses under the Royal School of Law & Administration.

1.2 The chairperson briefly summarized the objectives of the meeting :

- That, the course structure of BA.LLB(H) for the batch 2018 onwards be i) finalized complying the set norms of both Bar Council of India and CBCS system under the UGC grants Commission.
- That, the course structure of BA. LLB(H) for the existing batch of 2017, be ii) enhanced and standardized on the lines of CBCS system.

1.3 Discussions/Deliberations:

1.3.1 COURSE STRUCTURE (new)

- i. After extensive discussions on the choices to be provided as MAJOR (B.A) subject, it was concluded that, SOCIOLOGY should be made compulsory for all. The rationalization between this interdisciplinary approach shall have reaching contributions to the society. Also communicative English under the CBCS, is already spread out over the six semester term period.
- ii. After cautious contemplation upon the choices to be provided in regards to the major subjects, it was a unanimous conclusion, that English, Psychology, Economics shall be provided.
- iii. After a thoughtful insight upon the credit per subject, it was concluded, keeping in mind the vulnerability of the just passed HS level students that
 - a) Major : 04 credits
 - b) Minor: 03 Credits
 - c) Law subjects: 05 credits
- Thus it was categorically clear that -1st semester = 22 Credits
 2nd Semester- 22 Credits.
 With no changes in the sequence of the proposed law papers.
- v. That the proposed sequences law papers were : 3rd Semester: Constitutional Law-I, IPC, Family Law-I.
 - 4th Semester: Constitutional Law -II, CrPC, Family Law -2
 - 5th Semester: Labour Law-I, Law of Evidence, CPC.
 - 6th Semester: Labour Law- II, Administrative Law, Company Law.

After considering the ardous level of the substantive law subjects, it was suggested that the sequence would be in the following manner:

- 3rd Semester: Constitutional Lwa- I, Labour Law I, Family Law-1.
- 4th Semester: Constitutional Lwa- II, Labour Law II, Family Law- II
- 5th Semester: CPC, Company Law, Administrative Law
- 6th Semester: IPC, Law of Evidence, Cr.PC.
- vi. That to compare with the BCI Rules in regard to distribution of BA Course/ subjects and law papers / subjects as mentioned under Schedule-I of Rules for legal education 2008, during the term of the 4th semester the following B.A Subjects shall be introduced which shall continue uptill 6th semester.
 - ≻ History-I (03 credits) (4th)
 - Political Science-I (03 credits) (4th)
 - ➤ History –II (03 credits) (5th)
 - Political Science-II (03 credits) (6th).
- vii. Thus, it was categorically clear that 3rd Semester- 30 credits

4th Semester- 28 credits

- viii. That, it was proposed to the board- introduction of the Honors Category (Elective- Constitutional Group and Criminology Group) at the Fifth Semester, to which the Board unanimously consented.
 - ix. That, it was categorically clear that-5th Semester =28 credits
 6th Semester= 28 credits
 - That, according to Schedule-I of Rules for Legal Education 2008, the distribution of subjects are mentioned as-7th Semester [01 (first degree) + 04 (law subjects)] However, after intense meticulous scrutiny it was found that, the rules is ambiguous in regard to justification of a first degree paper (BA) at the 7th Semester.

Also, on further comprehensive inspection of the leading contemporary University, it was validly found that, the continuation of first degree papers at a much higher semester is a futile and irrelevant exercise.

- xi. That, as a choice to be provided under optional paper- "Tribal laws" should be ministered.
- xii. That, in the detailed syllabus of the subject "Trade Law", GST should be introduced in a unit.
- xiii. That, the optional papers ministered should be in such a pattern and sequence, which should not lap over the subject under elective Hons. Group.
- **1.3.2** That, the batch of 2017, commenced with a full scale gravid implementation of CBCS, totaling to 32 credits for both 1st and 2nd Semester, following changes were placed on board for deliberation.
 - a) Since, 04 major papers have already been administered in the 1st & 2nd Semester, the balance (02) papers are proposed to be taught in the 3rd & 4th Semester (01 each semester), leading to completion of sum total of 06 papers in major group.
 - b) To, comply with the distribution of B.A papers and Law papers at the 5th & 6th Semester, a additional subject "Legal Language" -I & II are to be introduced.

ii) After, intricate contemplation and keeping in mind the final embodiment of the legal acumen required by a student legal science, it was concluded that-

- (a) The balance of 02 papers of the major group shall be on 01 per semester for the next academic year i.e 2018-201 (04 credits).
- (b) The sequence of the law papers shall be the same as point no.[C v].
- (c) The detailed syllabus for the clinical paper 'Drafting Pleading & Conveyancing' shall include a unit separate dedicated to Legal language.

(d) All other details shall remain same as the course structure of the new batches.

1.3.3 INTRODUCTION OF NEW GE COURSES:

New subjects introduced are: Elements of Indian constitution (1st sem), Fundamentals of Criminal Law (2nd sem), Principles of Environmental Law (3rd sem), Cyber Law and Cyber Crime (4th sem), Legal Literacy (Odd sem), Socio-economic Offences (even sem).

DETAILED SYLLABUS 1.3.4

JURISPRUDENCE

- Natural Law theory, a part of the third unit should be included in the second (i) unit.
- Scandinavian perspective of Realist School can be removed.
- Number of jurists under Analytical School should be less and be shifted to the (ii) (iii) third Unit.

CONSTITUTIONAL LAW

- Forms of Government should be included.
- Correction of the terms 'Indian Constitution of India' (i) (ii)

That, the remaining syllabus for the third and fourth semester stands approved by the board. The above modifications are suggested to be made.

That, for further enhancement of the syllabus of the upcoming semester, it was decided by the board to schedule the next meeting of the board of studies after Nov. 15th 2018.

2.1 Welcome Address

Dr. H.C. Nath (Chairperson) extended greetings to the members of the board. He expressed his gratitude to Former Justice Mr. Biplab Kumar Sarma (Industry Expert) and Dr. Aparajita Baruah (External Expert), who accepted to be a part of BOS-II to finalize and streamline various aspects of B.ALL.B(H) and LL.M. courses under Royal School of Law and Administration.

2.2 Rectification/implementation of 1st BOS/ Feedback analysis

Necessary changes up to 70% in the contents of the subjects as well as changes in the syllabus structure were carried out as per the recommendations of the experts in the first BOS meeting. Action taken report was presented and it was approved by the BOS without any further modification. (Annexed as Annexure I).

2.3 Objectives

The chairperson briefly summoned objectives of the meetings that the updating and incorporation of the necessary changes into the syllabus for BALLB and LLMcourses. The dissertation guidelines for the LLM course will be finalized

2.4 Discussions and Deliberation:

Members of BOS made discussions on the entries mentioned in the agenda. The discussions resulted in the following:

- 2.4.1 The Total contact periods of the LLM course structure are increased by one in each paper.
- 2.4.2 In the syllabus of BALLB semester IV the changes made are:
 - a. Paper: History–I:KautilyanArthashastra to be inserted. Administrative apparatus in vedic age to be dropped. Rules of marriage and patriliny to be dropped. Unit 3 to be subject specific. Unit 4 elemination of Manu and Yajnavalka and in lieu of which Narada to be included. Hanafi school to be removed.
 - b. Paper: Constitutional Law –II: Unit 2, gay rights and live in relationship to be eliminated. Shorten the portion of Fundamental rights. To mention the writs in the syllabus without the expansion. To insert writ jurisdiction in private sector. With judicial review and judicial activism to be clubbed.

- c. Paper: Labour Law-II: Payment of Bonus act to be strucked down, equal remuneration act to be shifted to unit 3.
- 2.4.3 Modifications in the syllabus of BALLB second semester including units: No changes were recommended
- 2.4.4 Modifications in the syllabus of second semester LLM:
 - a. In unit 3 of administrative law Aristotle is to added.
 - b. In unit 1 of administrative law natural justice system to be added.
 - c. In Local self Government unit 3 political empowerment to be inserted.
 - d. In criminal justice system and human rights sections 41 to 60 of the CrPC to be added.
 - e. Insertion of NLSAA in the same paper as iv (d).
 - 2.4.5 Changes in the course structure: No changes were recommended in the course structure of Both BALLB and LLM course structure
 - 2.4.6 Adopting some innovative strategy for internal assessment: Seminar presentations and Group discussion were recommended to enhance the oratory skills of the students
 - 2.4.7 In which two papers LTP's to be continued for second semester: LTP's to be submitted on the compulsory paper and one from each specialization group.
 - 2.4.8 Approval of Dissertation Guidelines: the proposed guidelines with minor changes stands approved.

For other papers also recommendations to make them concise were made by the experts.

- 3.3.2 Regarding the existing syllabus it was said to be appropriate except for a few parts to be concise.

- Practical Paper Drafting, Pleading and Conveyancing with Code-Law122C901 of 9th Semester may be shifted to 8th Semester and recoded as Law122P₂803.
- 3. Practical Papers with Code-Law122 C 902- Moot Court and Internship (CLI-III) may be recoded as Law 122P₃902 and Professional Ethics with Code- Law 122C1001 may be recoded as Law122P₄1001 respectively.

- 5. Internship may be introduced from the very beginning of the course for the students of BA.LL.B Programme.
- 6. In Labour Law-I, Code- Law122C303, Industrial Relations Code, 2020 may be inserted initially in Module II. Moreover, Occupational Safety, Health and Working Conditions Code, 2020 may be inserted initially in Module III.
- 7. In Paper Introduction to Intellectual Property Rights-II with Code- Law122D609, the Protection of Plant Varieties and Farmers Rights Act, 2001 may be inserted in Module III.
- 8. Honours subjects may be offered in any 3 (three) disciplines i.e. CL Group, Crl Group and IPR Group. If a student chooses Honours subject initially in any one of the above group, then he/she should not be offered a subject coming under Honours group in any Optional group. If this sequence is followed then in a specific subject the students obtain Honours without clash in optional subject.
- 9. If a student pursues law for 1 (one) year out of five-Year Integrated Course, then he/she may be awarded one certificate titled as "Certificate of Basic Law" subject to the guidelines issued by Bar Council of India with due approval to such certificates. Though NEP, 2020, issues guidelines in that regard but BCI approval is a must to give weight to such certificates.
