Under this contract, the list of projects envisaged are:

1. Building a barrack for shelter from floods for forest guards of Pobitora Wildlife Sanctuary
2. Provision of drinking water in a flood-affected village
3. Capacity-building in coracle making to facilitate intra village mobility during floods
4. Restoration and preservation of an ancient prayer house
5. Provision of emergency lamps and mobile charging facilities across households of two villages

We intend to implement the above projects via contracted local organizations with an on-ground presence. A detailed Project proposal, approved by the funder, is attached along with this letter.

We would be very grateful if you would lead us on this project as a **Senior Strategic Consultant**. Your expertise, vast networks and experience would add immense value to our work. The illustrative representation of the responsibilities associated with this role are envisaged below:

1. Project guidance and overall management

3. Strategic oversight and management of the advisory team
4. Joint management of the implementation team

We have fixed a consultancy fee of Rs 50,000/- per month for this role. The Project is expected to last for 12 months at the minimum.

Project Completion Report: Building Flood-Resistant Housing for Forest Rangers in Pobitora Wildlife Sanctuary, Morigaon District, Assam

Project Overview:

This report presents the comprehensive completion of the social impact project aimed at constructing flood-resistant housing for forest rangers in the Pobitora Wildlife Sanctuary, Morigaon district, Assam. The project was initiated with the generous funding and support from the Gerda Henkel Stiftung.

The primary objective of the project was to provide safe and resilient housing for forest rangers who are crucial in safeguarding our natural resources and ecosystems, particularly during times of flooding.

The project was launched in response to the recurring challenges faced by forest rangers residing in flood-prone areas. These individuals play a vital role in conservation efforts and wildlife protection within forests, yet their housing conditions are inadequate and vulnerable to natural disasters such as flooding caused by swollen rivers during the monsoon months. Recognizing this issue, our project aimed to address the housing needs of forest rangers by constructing flood-resistant homes equipped with all necessary amenities like electricity, running water and basic sanitation.

Over the course of implementation, our team successfully completed the construction of 6 flood-resistant units which can house up to 22 individuals. 4 family units designed to accommodate 4 members per family along with 2 units housing 3 individuals each.

Key achievements:

1. Construction of Flood-Resistant Houses: The cornerstone of our project was the construction of flood-resistant housing units designed to withstand the impact of flooding. Through meticulous planning and collaboration with local authorities and construction experts, we successfully built 6 units meeting stringent safety standards. These houses are elevated to mitigate flood risks and are equipped with resilient materials and infrastructure.
2. Integration of Sustainable Practices: Sustainability was at the forefront of our project. Each housing unit was designed with eco-friendly principles in mind. The units have been designed to help the Forest department incorporate features such as rainwater harvesting systems, solar panels for energy generation, and efficient



waste management solutions in future. These measures not only enhance the resilience of the houses but also contribute to environmental conservation efforts.

3. Community Engagement and Capacity Building: Throughout the project, we prioritized community engagement and participation. Local residents, including forest rangers and their families, were actively involved in the planning and construction processes. Additionally, capacity-building sessions were conducted to impart knowledge on sustainable living practices, and maintenance of the housing units.
4. Monitoring and Evaluation: Continuous monitoring and evaluation mechanisms were implemented to ensure the quality and effectiveness of the project. Regular inspections were carried out during the construction phase, and post-construction assessments were conducted to gauge the resilience of the structure. Feedback from the forest rangers and community members was incorporated into project improvements and future initiatives.

Expected Impact:

The project is expected to generate significant positive impact at various levels:

1. Enhanced Safety and Well-being: The newly constructed flood-resistant housing units will provide a safe and secure living environment for forest rangers and their families, reducing their vulnerability to natural disasters and improving their overall well-being.
2. Improved Resilience: By integrating resilient design features and sustainable practices, the housing units are better equipped to withstand floods and other environmental challenges, ensuring the continuity of operations and services provided by forest rangers.
3. Empowerment and Community Cohesion: Through community engagement activities and capacity-building initiatives, the project will empower local residents with the knowledge and skills to address disaster risks and promote sustainable living practices. This will foster a sense of ownership and cohesion within the community.
4. Environmental Conservation: The adoption of sustainable technologies and practices not only benefits the residents but also contributes to environmental conservation efforts, promoting a harmonious relationship between human settlements and natural ecosystems.



Commitment to Sustainability:

The project not only addresses the immediate need for safe living conditions but also embodies a commitment to sustainable development. Incorporating sustainable practices in construction ensures minimal environmental impact, promotes resource efficiency, and enhances the resilience of the built environment to climate-related risks. This section elaborates on the sustainable practices utilized in the construction process:

1. Eco-Friendly Building Materials

Bamboo: Bamboo, a rapidly renewable resource abundant in the region, was utilized for structural components and cladding. Its lightweight yet robust properties make it ideal for construction while minimizing the carbon footprint associated with traditional building materials.

Locally Sourced Materials: Materials sourced locally, such as clay, stone, and timber, reduce transportation-related emissions and support the local economy. By prioritizing indigenous materials, the project promotes sustainable practices and strengthens community resilience.

2. Resilient Design Features

Elevated Foundations: Housing units were constructed on elevated platforms to mitigate flood risks, allowing water to flow beneath the structures without causing damage. This design feature enhances resilience to flooding while preserving the integrity of the habitat and minimizing disruption to wildlife.

Roof Overhangs and Rainwater Harvesting: Extended roof overhangs were incorporated to provide shade and protection from heavy rainfall, reducing the risk of erosion and water ingress. Provisions have also been made for the future installation of rainwater harvesting systems to capture and store rainwater for household use, promoting water conservation and self-sufficiency.

3. Energy-Efficient Solutions

Passive Solar Design: Housing units were designed with orientation and window placement optimized for passive solar heating and natural ventilation, reducing the reliance on mechanical heating and cooling systems. This approach not only minimizes energy consumption but also enhances thermal comfort for occupants.

Solar Panels: Provisions have been made for the future installation of Solar panels on the roofs of housing units to harness renewable energy for lighting and electrical appliances. By utilizing solar power, the project reduces reliance on fossil



fuels, mitigates greenhouse gas emissions, and contributes to climate change mitigation efforts.

4. Waste Management and Recycling

Construction Waste Recycling: Construction waste, such as timber offcuts and packaging materials, was segregated and recycled whenever possible. By diverting waste from landfills, the project minimizes environmental pollution and conserves natural resources.

Composting and Organic Waste Management: Composting facilities were established to manage organic waste generated during construction and daily operations. Composting not only reduces waste sent to landfills but also produces nutrient-rich soil amendments for use in landscaping and agriculture.

5. Community Engagement and Capacity Building

Training and Education: Community members, including forest rangers and construction workers, were provided with training on sustainable construction practices, emphasizing techniques for resource conservation, waste reduction, and environmental stewardship.

Participatory Approach: The construction process adopted a participatory approach, involving local residents in decision-making and implementation. By engaging the community throughout the project lifecycle, the initiative fosters a sense of ownership, empowerment, and long-term sustainability.

Conservation of Natural heritage:

The project has had both direct and indirect impacts on the wildlife and natural habitat of the sanctuary. While the primary objective of the project was to improve living conditions for forest rangers, it is essential to evaluate its implications for the ecological integrity and biodiversity conservation within the sanctuary:

1. Direct Impacts

Habitat Alteration: The construction of housing units, access roads, and associated infrastructure may have led to habitat alteration and fragmentation within the sanctuary. Clearing of vegetation, excavation, and earth-moving activities associated with construction can disrupt natural habitats and wildlife corridors, potentially affecting the movement and behavior of wildlife species.



Noise and Disturbance: Construction activities, including machinery operation, vehicle movement, and human presence, can generate noise and disturbances that may adversely impact sensitive wildlife species. Increased human activity in the vicinity of wildlife habitats can disrupt feeding, breeding, and nesting behaviors, leading to stress and displacement of wildlife.

Water Quality and Pollution: Construction-related activities such as soil erosion, sedimentation, and runoff can degrade water quality in nearby water bodies, impacting aquatic ecosystems and wildlife dependent on them. Disposal of construction waste and pollutants may further exacerbate pollution levels, posing risks to aquatic fauna and flora.

2. Indirect Impacts

Habitat Fragmentation: Infrastructure development associated with housing construction, such as roads and pathways, can fragment contiguous habitats, restricting the movement of wildlife and reducing habitat connectivity. Habitat fragmentation can isolate populations, increase edge effects, and limit gene flow, thereby impacting biodiversity and ecological resilience.

Human-Wildlife Conflict: The presence of human settlements and associated activities can potentially escalate human-wildlife conflicts, particularly in cases where wildlife species encroach upon human-inhabited areas in search of food or shelter. Such conflicts may lead to retaliatory killings, habitat degradation, and disruptions in wildlife behavior and distribution patterns.

Resource Utilization: Increased human presence and infrastructure development may lead to intensified resource utilization, such as fuelwood collection, grazing, and poaching, which can exert additional pressure on natural resources and wildlife populations. Unsustainable resource extraction practices can degrade habitats and threaten the survival of vulnerable species.

3. Mitigation measures and favorable impact

Despite these potential challenges, the project is expected to have a net positive impact on the wildlife and natural habitat of the sanctuary. This assessment stems primarily from improved management practices, enhanced protection measures, and sustainable development initiatives associated with the housing project. These measures are discussed in more detail here:

Reduced Human-Wildlife Conflict: By providing secure housing for forest rangers within the sanctuary, the project helps mitigate human-wildlife conflicts. Forest rangers play a crucial role in wildlife management and conflict resolution, and their



presence within the sanctuary helps deter illegal activities such as poaching and encroachment, thereby reducing disturbances to wildlife.

Enhanced Wildlife Monitoring and Protection: The presence of forest rangers in close proximity to wildlife habitats facilitates enhanced monitoring and protection efforts. Forest rangers can more effectively patrol the sanctuary, deter illegal activities, and respond promptly to wildlife emergencies or threats. This increased surveillance contributes to the overall conservation and well-being of wildlife populations.

Improved Habitat Management: The construction of flood-resistant housing may necessitate habitat restoration and enhancement activities, including reforestation, soil stabilization, and invasive species control. These efforts can help improve the quality and resilience of wildlife habitats within the sanctuary, providing better food and shelter resources for native fauna.

Strengthened Ecotourism and Conservation Awareness: The presence of well-equipped forest rangers and improved infrastructure within the sanctuary can enhance ecotourism opportunities and visitor experiences. Ecotourism initiatives generate revenue that can be reinvested into conservation efforts, habitat restoration projects, and community development programs. Additionally, increased visitor engagement fosters greater awareness and appreciation for wildlife conservation and environmental stewardship.

Promotion of Sustainable Practices: The construction of flood-resistant housing incorporates sustainable building materials and design features, promoting eco-friendly practices within the sanctuary. This commitment to sustainability extends to waste management, energy efficiency, and water conservation measures, reducing the ecological footprint of human activities and minimizing disturbances to wildlife habitats.

Community Engagement and Stewardship: The provision of housing for forest rangers fosters a sense of community engagement and stewardship among local residents. Forest rangers serve as ambassadors for wildlife conservation, working collaboratively with neighboring communities to address conservation challenges and promote sustainable livelihoods. This collaborative approach strengthens social cohesion and empowers local communities to actively participate in conservation efforts.

In summary, the project effectively balances the needs of human communities with those of wildlife and ecosystems, contributing to the long-term conservation and resilience of this biodiversity-rich sanctuary.



Conservation of Man-made heritage:

The project is expected to have several favorable impacts on the culture and man-made heritage of the local communities inhabiting the Mayong area as well as the wider Morigaon district.

1. Preservation of Traditional Knowledge and Practices

This strengthens community resilience, promotes intergenerational knowledge transfer, and preserves indigenous cultural heritage.

4. Conservation of Historic Sites and cultural landmarks

Mayong is home to several historic sites, cultural landmarks, ancient temples and archaeological relics dating back several hundred years. The presence of forest rangers in the area facilitates improved protection and conservation of these heritage assets, safeguarding them from encroachment, vandalism, and environmental degradation. Enhanced monitoring and surveillance contribute to the preservation of Mayong's unique cultural identity and historical legacy.

5. Integration of Traditional Architecture and Design

The construction of flood-resistant housing has incorporated elements of traditional architecture and design prevalent in the Morigaon district. By integrating indigenous building materials, craftsmanship, and architectural styles, the housing units blend harmoniously with

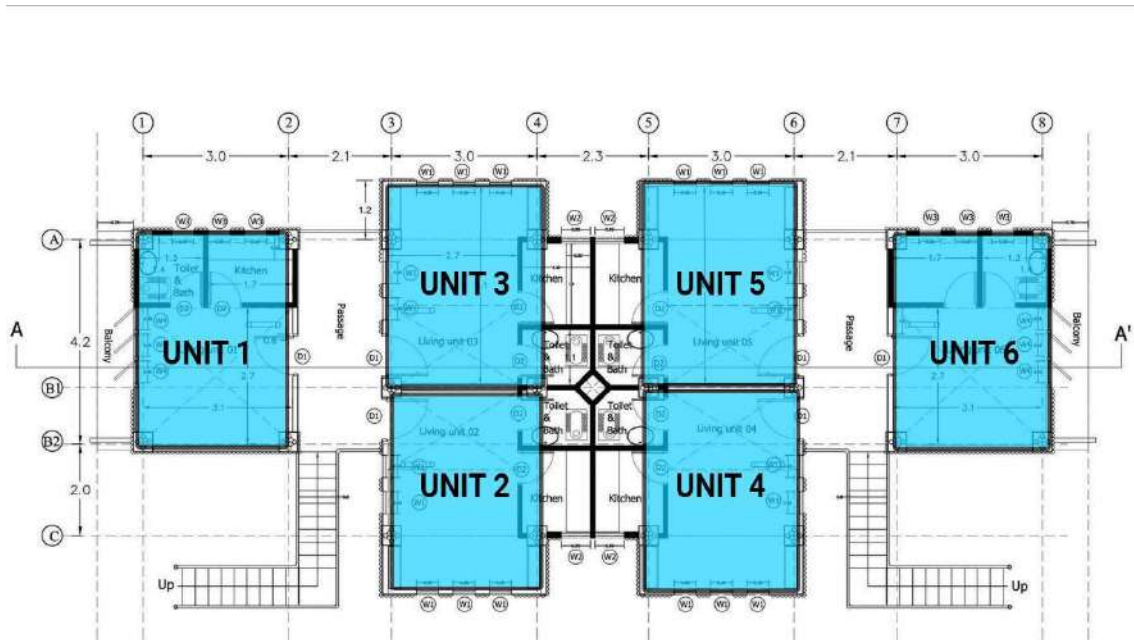


the cultural landscape, reflecting the unique identity and heritage of the local communities. This approach celebrates cultural diversity and promotes pride in indigenous craftsmanship.

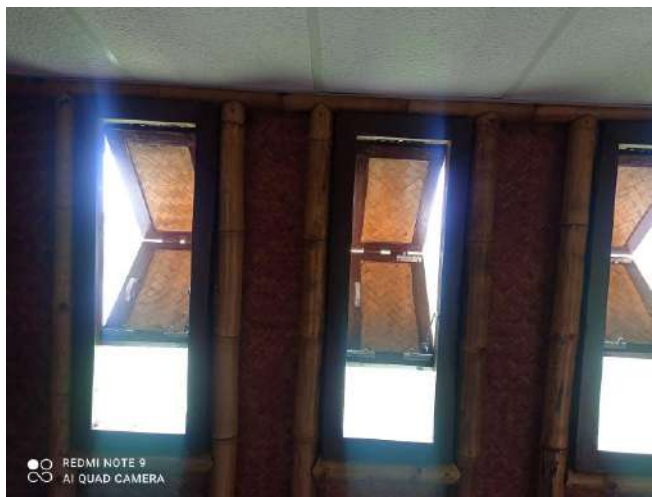
