



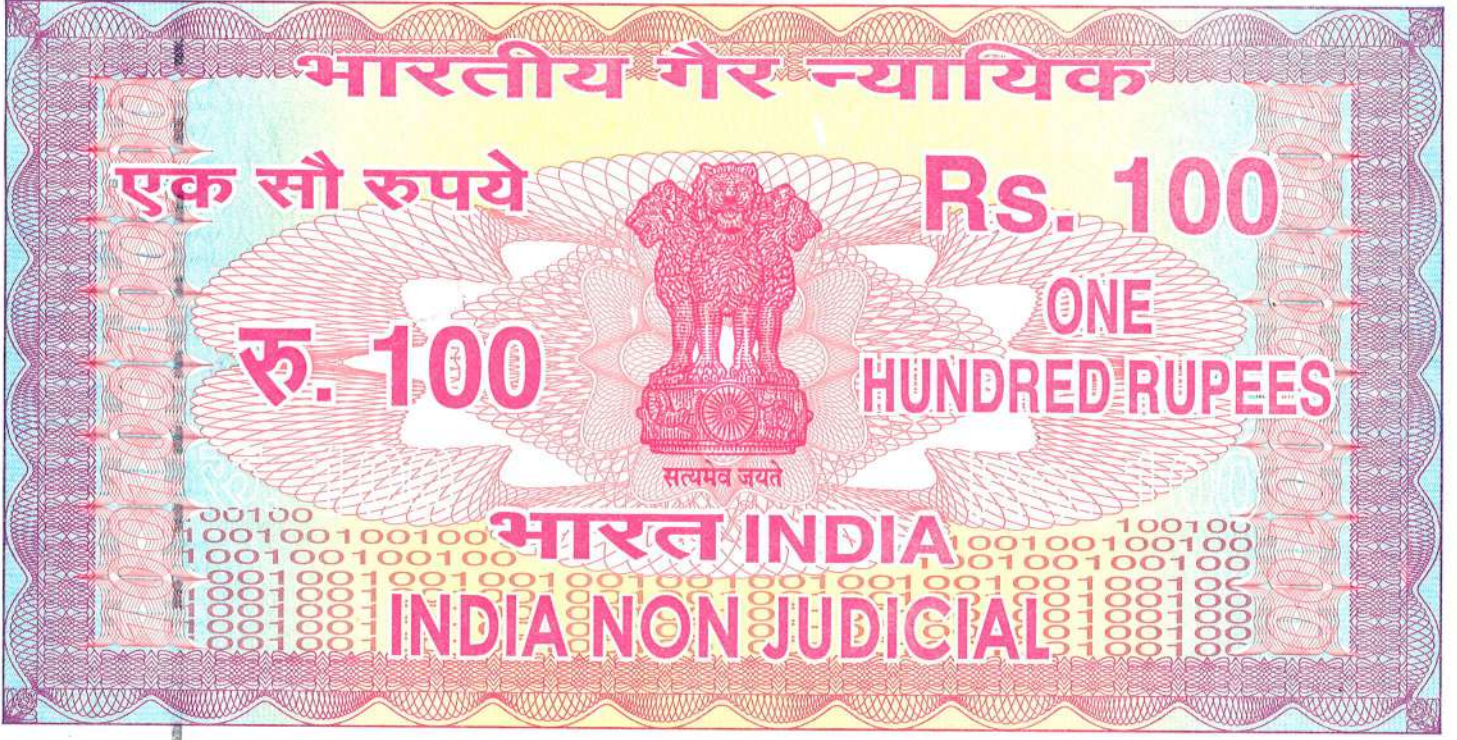

This Memorandum of Understanding (MoU) is executed on this day 25th April 2023 between **Assam Academy of Mathematics (AAM)**, Assam, herein after referred to as “**First Party/AAM**”, a non-profit Academic Voluntary organization was established on July 18, 1986, and registered under the Society Registration Act XXI of 1860 to promote and popularize mathematics education and research in Assam. The academy has more than twelve hundred life members, twenty-two active branches, and forty-seven Olympiad examination centres. Assam Academy of Mathematics regularly conducts state-level mathematics Olympiads, academic lectures, and training programs for students and teachers. The Academy also frequently conducts competitions on mathematics-related topics, namely, quizzes, exhibitions, essay writing, speech etc., to popularize and grow more interest in mathematics among students.

2. Anticipated Mutual Benefits & Interests

- 2.1 Together, both parties shall work towards furthering cooperation in both education, training & research, which will be mutually beneficial to both the organization and the people of the region.
- 2.2 The two organizations shall work in cooperation for research activities; conduction of training programs; summer/winter programs; extension activities; guiding students in internship program; bringing out joint publications & sharing of permissible information.
- 2.3 Together both parties will popularize mathematics education with different extension activities/ holding classes for mathematics Olympiad or any other activities as agreed upon by both organizations.

3. Types of Cooperation

The Department of Mathematics, The Assam Royal Global University and Assam Academy of Mathematics envisage the following cooperation within the scope of this Memorandum of Understanding (MoU):






- i) **Scientist and Faculty support for both the organizations:** Scientist of AAM may be involved as esteemed members on the Board of Studies of relevant discipline and maybe empaneled as distinguished Visiting Faculty in some identified relevant schools/departments in consultation with RGU. Similarly, RGU being a multi-disciplinary institution is agreeable to extend any academic expertise on request.
 - ii) **Resources sharing:** AAM may consider accommodating some selected students from RGU to do their projects under guidance of faculty members on mutually agreeable terms.
 - iii) **Co- guidance:** There shall be a provision for co- guidance by experts of AAM/RGU as per universities norms.
 - iv) **Joint Research:** There shall be a finite possibility of conducting joint research involving the faculty and scientists of both the institutions on mutually agreed upon areas/fields of research.
 - v) **Joint Research Projects:** Faculty members and scientists of both the organizations may jointly work on externally sponsored projects on chosen areas of interest and expertise.
 - vi) **Seminars/Symposia/Workshop:** The two academic institutions may jointly organize Seminars/ Workshops/ Symposia on topics/themes of contemporary importance.
 - vii) **Short Term training programs:** RGU faculty/staff/students may be enabled to take part in ongoing continuing education programs, conducted by AAM with prior approval. Similarly, the same provision may be provided by RGU to AAM members, if sought for.
 - viii) **Guidance in infrastructure development:** Extension of technical co-operation in the form of knowhow from AAM for infrastructural development, management and upgradation of library and teaching /research laboratory facilities for students of Mathematics at RGU as and when requested.
4. **Financial Commitment or Obligations:** There will be no financial obligations from both the universities under this agreement. However, in the process of operation of the MoU some genuine expenditures may be incurred. This can be

5. **Institutional Coordinators:** Each organisation shall nominate a coordinator to facilitate the implementation of any agreements arising out of this MoU.
6. **Intellectual Property Rights (IPR):** RGU and AAM agree to respect each other's right to intellectual property as per conventional IPR rules. Further, all rights linked to discoveries, ideas, inventions, and patents generated during the MoU, shall remain the common intellectual property of the participating organizations. Both Parties shall not pass on and give usage rights of such property to any third party without prior approval of each other. The copyright over any publication, document, research paper etc. arising out of the collaborative works conducted by both the parties, will be jointly owned. However, the use of official emblem or logo on these publications, documents, research papers etc. will require permission to ensure that official emblem or logo is not misused.
7. **Dispute Settlement:** In the unlikely event of any dispute or difference arising under this Agreement, the Parties shall try to discuss and arrive at an amicable resolution. If the Parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute, the matter shall be referred to arbitration by a single arbitrator appointed pursuant to the Arbitration and Conciliation Act, 1996. The jurisdiction of arbitral proceedings and place of execution of the deed shall be in Guwahati and the language of arbitration shall be English. The Parties agree that the decision of the arbitrator shall be final and binding on the Parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.
8. **Liability:** Except for loss or damage caused through gross negligence or intent, the Parties shall have no liability to each other hereunder.
9. **Confidentiality:** All the confidential information shall remain the exclusive property of the disclosing party. A party will not use the confidential information for purposes other than the specified without the prior written consent of the other party.
10. **Force Majeure:** Neither party shall be held responsible for non-fulfilment of their respective obligations under this MOU due to the exigency of one or more of the *force majeure* events such as but not limited to eventualities like floods, earthquakes, strikes, bandhs, lockouts, epidemics, riots and commotions, etc. provided on the occurrence and cessation or cessation of such events, the party

This Memorandum of Understanding (MoU) is executed on this ~~15~~¹⁵ day of ~~OCTOBER~~^{OCTOBER} 2021 between **CSIR-North East Institute of Science and Technology (NEIST)**, Jorhat, Assam, herein after referred to as “**First Party/CSIR-NEIST**”, a constituent establishment of Council of Scientific and Industrial Research (CSIR), Ministry of Science & Technology, Government of India, New Delhi. CSIR-NEIST has been engaged in multidisciplinary R&D work relevant to the country in general and North Eastern Region in particular. The CSIR- North East Institute of Science and Technology, formerly (RRL), Jorhat was established in the year 1961 as one of the multidisciplinary laboratories of the CSIR under its Chemical Science Group of laboratories.

And

The Assam Royal Global University, a state private University, established by The Assam Royal Global University Act 2013 (to be read with The Assam Private Universities Act 2007), notified by the Government of Assam Gazette on 23/8/2013, herein after referred to as “**Second Party/RGU**”, having its campus at Betkuchi, NH-37, Guwahati-781035, Assam. Starting its first academic session from July 2017, RGU currently offers multiple courses in diversified fields of Science, Engineering, Architecture, Humanities and Social Sciences, Pharmaceutical Sciences, etc. Established in July 2009 as Royal Group of Institutions, this institution which has now been upgraded to the level of a university has seen remarkable growth, accompanied by excellent academic results and successful alumni placed in reputed corporate houses.

CSIR-NEIST and RGU are hereinafter collectively referred to as ‘Parties/Institutions’ and individually as ‘Party/Institution’.

1. Purpose:

That the broad objective of this agreement is to have a common platform for Research and Innovation/Scientist and/or Research Student Exchange Program/Summer & Winter Internship/ Collaborative Projects/Joint Consultancy/Joint Training Programs/Other activities as agreed upon by both parties, etc.

2. Statement of Mutual Benefits & Interests:

- 2.1 Together, these two parties shall work towards furthering cooperation in education, training & research which will be mutually beneficial for both the organization and for the people of the region.
- 2.2 Parties shall work in cooperation for research activities; joint training programs; exchange of faculty/scientist members; summer/winter programs; student exchange; exchange of joint publications & sharing of permissible information and laboratory facilities.

3. Forms of Cooperation:

The Parties envisage the following cooperation within the scope of this Memorandum of Understanding (MoU):

- a) **Scientist and Faculty support for both the parties:** Scientist of CSIR-NEIST may be involved as esteemed members on the Board of Studies of relevant discipline and maybe empaneled as distinguished Visiting Faculty in some identified relevant schools/ departments in consultation with RGU. Similarly, RGU being a multi-disciplinary institution is agreeable to extend any academic expertise on request.
- b) **Resources sharing:** CSIR-NEIST may consider accommodating some selected students from RGU to do their projects/thesis work at CSIR-NEIST subject to availability of the labs, consumables, and other infrastructure facilities, on mutually agreeable terms. Similarly, such a provision may be extended to CSIR-NEIST students by RGU, if sought for. Under such circumstances, students and faculty members shall be able to use facilities of either institute such as sophisticated equipment, library etc. after obtaining due approval from relevant authorities of CSIR-NEIST/RGU.
- c) **Joint guidance:** There shall be a provision for joint guidance by experts of CSIR-NEIST/RGU as per universities norms.
- d) **Joint Research** - There shall be a finite possibility of conducting joint research involving the faculty and scientists of both the institutions on mutually agreed upon areas/fields of research.
- e) **Joint Research Projects:** Faculty members and scientists of both the institutions may jointly work on externally sponsored projects on chosen areas of interest and expertise.
- f) **Seminars/Symposia/Workshop:** The two institutions may jointly organize Seminars/ Workshops/ Symposia on topics/themes of contemporary importance.
- g) **Short Term training programs:** RGU faculty/staff/students may be enabled to take part in ongoing continuing education programs, short-term trainings, and certificate courses of CSIR-NEIST with prior approval. Similarly, the same provision may be provided by RGU to CSIR-NEIST faculty/staff/students, if sought for.

- h) **Guidance in infrastructure development:** Extension of technical co-operation in the form of knowhow from CSIR-NEIST for infrastructural development, management and upgradation of library and teaching/research laboratory facilities at RGU as and when requested.
- i) **Publication-** CSIR-NEIST and RGU shall consult each other for any publication in respect of any project/course work. These publications shall be in the name of research worker, wherein the institutions will be duly acknowledged.
- j) **Accommodation-** To take care of accommodation facilities of CSIR-NEIST professionals by RGU and vice versa.
- k) **Joint Programmes-** Any expenditure incurred in the joint programmes will be borne as per mutual agreement.

4. **Financial Obligations:**

There will be no financial obligations on both the Parties under this agreement.

5. **Institutional Coordinators:**

The Parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.
- 6.4. The procedural formalities for securing and maintaining the intellectual property rights [patents/trademark/copyright] if any, shall be the responsibility of CSIR- NEIST and RGU. The question of whether or not intellectual property right should be secured shall be mutually decided.

The Assam Royal Global University, Guwahati and Digboi College hereinafter collectively referred to as 'the Parties/University & College' and individually as 'the Party/University/College'.

2. Purpose:

That the broad objective of this agreement is to have a common platform for Research / Faculty or Student Exchange Program/ Summer & Winter Internship/ Projects/ Joint Consultancy/ Joint Training Programs/ Other activities as agreed upon by both parties, etc.





3. Statement of Mutual Benefits & Interests:

- 3.1 Together, these two parties shall work towards furthering cooperation in both education, training & academic research which will be mutually beneficial for both universities.
- 3.2 Parties shall work in cooperation for research activities; joint training programs; exchange of faculty members; summer programs; student exchange; exchange of joint publications & sharing of information, etc.

4. Forms of Cooperation:

The Parties envisage the following cooperation within the scope of this Memorandum of Understanding (MoU):

4.1: Exchange of Faculty members

For planning and handling of academic programs and courses, organization of seminars, workshops and conferences including the exchange of mutual experiences in teaching, research and industrial practices with prior approval from parent university. Honorarium, transportation and accommodation/hospitality as per university/college norms.

4.2: Exchange in Research

4.3: Joint Submission of Collaborative Projects



Coming into Force, Amendment and Termination:

This MoU shall come into force from the date it is signed and shall remain valid for a period of three (03) years. This MoU may be modified, renewed or extended with the mutual written consent of the Parties. Either party may terminate this MoU with ninety (90) days of written notice before the end of the academic year.

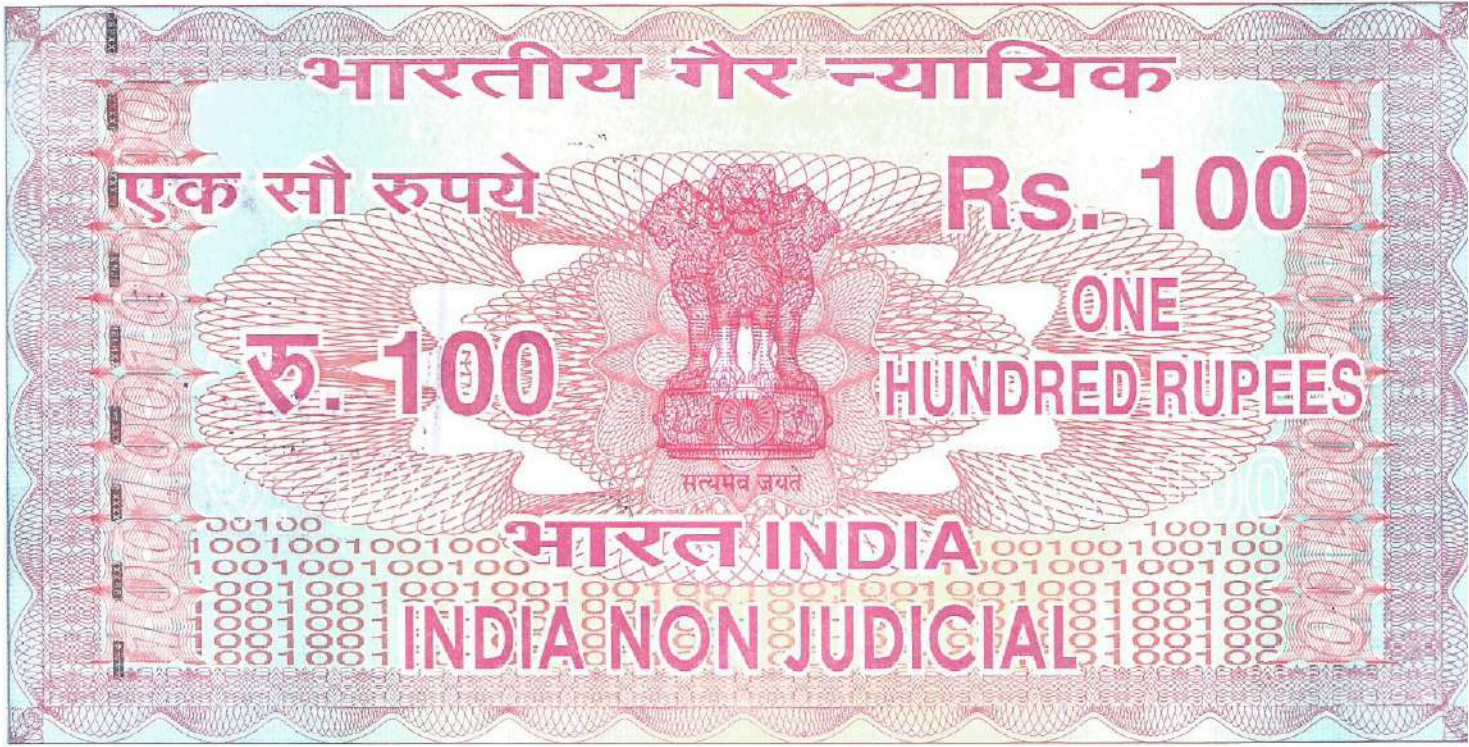

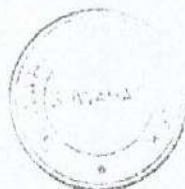

Guwahati Biotech Park (GBP), the first of its kind in Northeast India, a visionary initiative launched by Government of Assam to promote business in biotechnology and allied areas through entrepreneurship development particularly in the North-Eastern region of the country, herein after referred to as "Second Party/GBP". The objective of the park is to facilitate faster penetration of biotech industry and to accelerate the R&D activities in biotechnology and related fields with effective utilization of the rich natural resources of this region and to educate and utilize local human resources. The park, in its first step, has set up an Incubation Centre namely Guwahati Biotech Park Incubation Center (GBPIC) in the temporary premises of the park at IIT Guwahati campus through a joint initiative of the Department of Biotechnology (DBT), Govt. of India, the Government of Assam, and the IIT Guwahati. 1. Purpose and Objectives

The Assam Royal Global University (RGU) and the Guwahati Biotech Park (GBP) desire and intend to develop co-operation and collaboration in research for development, training, and other agreed activities of the Institutions as follows:

- a) To encourage, and use reasonable endeavors of each other to effect, without crossing the limitations of each other's resources, policies and procedures, visits from one Institution to the other by members of the academic, research and other staff for the purpose of participating in teaching, training, research for development programs and other agreed activities.
- b) To make use of GBP's facilities and services as per approved rates such as Sample testing (if applicable), Hiring Equipment, Leasing out space, etc. and in turn overall promotion of Biotechnology in the Northeast.

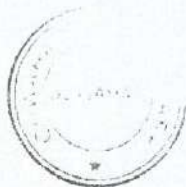

- c) To develop within the limitations of the Institution's resources, policies and procedures, collaborative work plans that specify the activities to be undertaken, objectives and targets, implementation mechanisms, roles and responsibilities, and resource contributions.
- d) To jointly explore external funding opportunities through project proposal development, thus enabling both Parties to expand and extend their collaborative activities.
- e) To provide, within the limitations of the Institutions' resources, policies and procedures, qualified students hosted by one institution access to research opportunities and/or degree programs at the other institution.
- f) To organize and conduct seminars, conferences, events, conclaves, annual conference and Business plan contest etc. in joint collaboration subject to the availability of funds.
- g) Conducting Hackathons or ideation events to encourage students to come up with ideas.
- h) To encourage the exchange of scientific materials, publications and information. The actual exchange of materials will be done on a purely voluntary basis and subject to required institutional Material Transfer Agreements.
- i) To encourage and support the start-up, incubation and development of innovation led, high growth knowledge-based business in the multidisciplinary area of biotechnology.
- j) Incubatees of both the organizations may avail the facilities and may visit the incubators to avail trainings and learnings from the expert, in addition residential workshops can be organized for the incubatees of the incubators. However, the costs incurred on the followings may be decided mutually.
- k) To provide formal and operational links with centers of knowledge creation such as National R&D laboratories, Universities, Medical Institutions and Research Organizations in India and abroad and create a strong network

- l) To facilitate creation/ development of new experimental and research/ training facilities through mutual co-operation of GBP and RGU through exchange of experts etc.
- m) Sharing the infrastructure facility for conducting R&D works leading to entrepreneurial venture in biotechnology and allied areas as per mutually agreed terms and conditions.
- n) Make best efforts to support startups from the region with knowledge and access to resources (e.g., incubation facility, technology labs), so that innovative ideas can be transformed into successful business ventures.
- o) Charges/fees/rent for the services wherever required by the service provider institute will be paid by the user party as per mutually agreed terms and conditions.
- p) Exchange of human resources/facilities/services between both the parties will only be within the scope of the agreed terms and conditions and is for the duration of this MOU and may be extended subject to mutual agreement between the parties.
- q) Each party shall bear its own share of expenses and costs of travel, boarding and lodging (if applicable) with regard to all discussions and activities between the parties.
- r) Both parties shall coordinate to the extent possible, within the constraints of their Organization's security provisions, reasonable access to their respective facilities as needed to facilitate any activities.
- s) Providing endorsement, support, and dissemination of information on activities, projects, requests for participation, etc.
- t) Create a state-wide inclusive entrepreneurial ecosystem.
- u) Promote entrepreneurship, create awareness, and motivate the youth.
- v) Facilitate external funding for startups.
- w) Provide physical and virtual incubation services.
- x) Helping in creation of direct and indirect employment.

2. Understanding between the two Parties

- a) Both parties acknowledge the need to create an ecosystem for promoting innovation and entrepreneurship and are interested in partnering to further this cause.
- b) There is a need to inculcate an entrepreneurial & problem-solving mindset among the students and youth
- c) Both parties understand and shall strive towards creating a support structure within the organizations so that students can nurture innovative entrepreneurial ideas.

3. Non exclusivity

The relationship of the parties under this MOU shall be non-exclusive and both the parties, including their affiliates, subsidiaries, and divisions, are free to pursue other agreements or collaborations of any kind.

4. Assignment

It is understood by the Parties here that this MOU is based on the professional competence and expertise of each party, and hence, neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

5. Intellectual Property Rights (IPR)

RGU and GBP agree to respect each others right to intellectual property as per conventional IPR rules. Further, all rights linked to discoveries, ideas, inventions, and patents generated during the MoU, shall remain the common intellectual property of the participating institutions. The parties shall not pass on or give usage rights of such property to any third party without prior approval of each other. The copyright over any publication, document, research paper etc. arising out of the collaborative works conducted by both the parties, will be jointly owned. However, the use of official emblem or logo on these publications, documents, research papers etc. will require permission to ensure that official emblem or logo is not misused.

6. Dispute Settlement

In the unlikely event of any dispute or difference arising under this Agreement, the Parties shall try to discuss and arrive at an amicable resolution. If the Parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute, the matter shall be referred to arbitration by a single arbitrator appointed pursuant to the Arbitration and Conciliation Act, 1996. The jurisdiction of arbitral proceedings and place of execution of the deed shall be in Guwahati and the language of arbitration shall be English. The Parties agree that the decision of the arbitrator shall be final and binding on the Parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

7. Force Majeure

Neither party shall be held responsible for non-fulfilment of their respective obligations under this MOU due to the exigency of one or more of the *force majeure* events such as but not limited to eventualities like floods, earthquakes, strikes, bandhs, lockouts, epidemics, riots and commotions, etc. provided on the occurrence and cessation or cessation of such events, the party affected thereby shall give notice in writing to the other party within one month of such occurrence or cessation. If the *force majeure* conditions continue beyond four months, the parties shall then mutually decide about the future course of action.

8. Termination of MoU

This MOU commences from the date of its signing and shall be in force for 3 years. The MOU may be terminated at any time by mutual consent or by 6 months' notice by either party. It may be amended, modified, extended, or renewed only by the written consent of both Parties. The Institutions agree to review this MOU six months prior to end of the 3-year term.

9. Confidentiality

- a) The parties to this MoU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the either party. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- b) Except as reasonably required, both the parties covenant that neither the party shall at any time during this MOU or at any time after it is terminated disclose or reveal to any person / organization or otherwise make use of confidential information

including any of the trade secrets, confidential operations, processes or dealings or any information concerning the parties and their subsidiaries, business, finances, transactions or affairs of the affiliates / agencies or any of their ventures which may come to the knowledge of either the party during the period.

- c) During the period of the MOU, each party agrees to respect each other's freedom of operation. Neither the parties shall interfere in the affairs / functioning of the other.

This MOU is not intended to create any legally binding obligations nor any financial commitment on either institution but, rather, is intended to facilitate discussions regarding general areas of cooperation as stated above.

AND

The Assam Royal Global University, a state private University, established by The Assam Royal Global University Act 2013 (to be read with The Assam Private Universities Act 2007), notified by the Government of Assam Gazette on 23/8/2013, herein after referred to as "**Second Party/RGU**", having its campus at Betkuchi, NH-37, Guwahati-781035, Assam. Starting its first academic session from July 2017, RGU currently offers multiple courses in diversified fields of Science, Engineering, Architecture, Humanities and Social Sciences, Pharmaceutical Sciences, etc. Established in July 2009 as Royal Group of Institutions, this institution which has now been upgraded to the level of a university has seen remarkable growth, accompanied by excellent academic results and successful alumni placed in reputed corporate houses.

'**ICAI**' and '**RGU**' are hereinafter collectively referred to as 'Parties' and individually as 'Party'.

WHEREAS the ICAI through its Council has constituted **Students Skills Enrichment Board (BOS-Operations)** (hereinafter referred to as '**SSEB (BOS-Operations) of ICAI**') with its objectives to recommend to the Council the policies governing IT and Soft Skills training, Industrial training and extra co-curricular activities of the students undergoing Chartered Accountancy Course and further to provide and monitor high quality practical education to students of Chartered Accountancy Course by making use of available recourses for benefit of the students.

WHEREAS ICAI is willing to organize Four Weeks Residential Programme on Professional Skills Development at RGU to help CA students in imbibing the professional skills required for effective functioning in evolving businesses and organizations focussing to develop communication, interpersonal, decision making, teamwork, creative problem solving and leadership skills amongst the students.

WHEREAS ICAI is in search of appropriate venues at various institutes having residential facilities for

conducting the said programme so that opportunity to the larger number of students to get benefit from the programme may be provided.

AND WHEREAS RGU approached the Guwahati Branch of the Eastern Regional Council of ICAI and offered its campus for CA students for conducting said Four Weeks Residential Program for CA students.

AND WHEREAS parties to the MoU are legally capable for entering into MoU for the Object, Scope and purpose of this MoU.

NOW THEREFORE the "Parties" are entering into an understanding, listing out broad areas of cooperation and methodology to put their endeavour to achieve the objectives of this Memorandum of Understanding (MoU).

By this MoU, the parties hereto have decided to cooperate; collaborate and further agree as under:

1. Objective

The objective of this MoU is to establish mutual co-operation between the parties in promoting excellence in professional education and conducting Residential Program on Professional Skills Development for the CA Students.

2. Scope of Co-operation

2.1. RGU will provide stay arrangements - Well equipped proper ventilated AC rooms on double/triple/ four bed sharing basis (based on availability) having proper lighting arrangements with adequate washroom.

2.2. The RGU will provide Room facilities - All residential rooms should have proper basic furniture including proper single beds with mattresses, bedsheets, comforters/duvet with covers, pillows with covers, towels, toiletries, two tables, two chairs & two cupboards with hangers, curtains, mosquito repellents etc. in each room and TV (LED) will be provided in the common room.

2.3. The RGU will provide Housekeeping facilities - There should be professional housekeeping services to clean the rooms, common area and washrooms on daily basis including on holidays. Bedsheets, pillow covers, comforters/duvet covers and towels etc. should be changed on regular basis.

2.4. The RGU will arrange a local laundry service provider outside the campus who will provide laundry services (washing and ironing). Payment to be borne by individual students.

2.5. The RGU will provide Canteen services - Proper hygienic canteen with adequate number of tables, chairs and decent cutlery for serving breakfast, lunch, dinner and tea/coffee/snacks etc. during the course. The canteen should be within the same residential premises in which the course is conducted by organising unit.

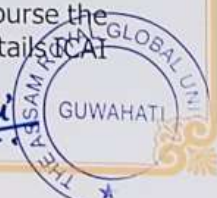

- 2.6. The RGU will provide Catering services - Hygienic vegetarian meals to be served with proper buffet arrangements. Breakfast, lunch, snacks and dinner to be served at the dining area at a scheduled time.
- 2.7. The RGU will provide Water through RO filters - There should be provision for RO filters along with water coolers for providing pure & healthy drinking water which can be used by the participants in their rooms as well.
- 2.8. The RGU will provide Library facilities - Proper library equipped with five desktops having high speed internet connections for the use of the participants after the classroom sessions.
- 2.9. The RGU will provide Wi-Fi facilities - The premises should have broadband high speed Wi-Fi connectivity which can be accessed by the participants in their rooms, classroom and common areas etc.
- 2.10. The RGU will provide CCTV facilities - Entire campus should be covered under CCTV coverage covering all the common areas for which the video recording should be preserved for at least 15 days.
- 2.11. The RGU will provide Recreational infrastructural facilities - Adequate arrangements for the outdoor recreational activities such as Yoga, Cricket, Basketball, Football, etc. and indoor activities such as Chess, Carrom, Table Tennis, Gymnasium etc. These which will be common with the existing University students.
- 2.12. The RGU will provide Classroom facilities –
- (i) Well ventilated AC Classroom with adequate lights arrangements.
 - (ii) Required setup preferably auditorium/theatre style seating having desks which can accommodate 40-50 students easily.
 - (iii) Proper projector alongwith adequate projection screen for giving presentation to the audience.
 - (iv) Podium with mike, lapel mike, cordless mike etc. with proper sound & speaker arrangements should be available in one room.
 - (v) Arrangements for two-way video conferencing should also be available with highspeed internet connectivity.
 - (vi) White board with marker, duster etc. should be available for running the classes.
 - (vii) Proper table with chair for faculty.
 - (viii) Inaugural lamp with required accessories for inaugural/valedictory session etc.
 - (ix) With respect to the facility for Video recording/photography on the first and last day of the course the cost of which would be borne by the ICAI, RGU will suggest a vendor and for rates and other details ICAI will negotiate with the Vendor directly.

2.13. The RGU will provide Security arrangements - The premises should be adequately covered under CCTV as mentioned at point No. 2.10. There should be arrangement of 24 X 7 security guards, hostel warden along with atleast one lady guard in case of female participants.

2.14. The RGU should have separate hostel wings for male and female participants. At a time either male or female students only will be accommodated.

2.15. The RGU will provide medical facilities - There should be provision for basic first aid facilities for the students. Under any extreme conditions, if any student needs to be hospitalised, RGU will not be involved in any financial obligations for admission/treatment of the students. The coordinator from ICAI will be directly dealing with the hospital for such matters.

2.16. The RGU will meet all Statutory Compliances - The building should be duly complied with all the statutory requirements including fire and safety.

2.17. The RGU will provide Faculty Stay - Two adequate befitting rooms for the stay of the faculty at the premises.

2.18 The ICAI at its own cost will arrange for coordinator(s)/ warden(s) and RGU, if so desired by the ICAI, shall permit their stay within the campus itself.

2.19. The RGU will provide Power Backup - 24X7 power backup for classroom(s) and residential rooms in case of power failure. AC facility won't be provided during power failure.

3. Implementation of the MoU

The RGU will nominate one representative at its premises to co-ordinate with the representatives of ICAI for the smooth functioning of the programmes.

4. Legal Obligations & Binding Nature of the MoU

Save as to the confidentiality obligations of the Parties under clause 5, this MoU expresses the intention of the Parties and does not give rise to legally enforceable obligations. Each Party shall use its best endeavours to implement this MoU in good faith and in accordance with applicable laws, regulations and principles of ethical conduct and integrity. The Parties declare that the signatories to this MoU are its authorised representatives, duly constituted in the form of their incorporation, with powers to assume the obligations agreed.

5. Confidentiality, Intellectual Property and Use of Name and Logo

5.1. Each Party shall undertake to observe the confidentiality and secrecy of documents, information and other data received from or given to the other Party during the period of the implementation of this Memorandum of Understanding or any other agreements made pursuant thereto.

5.2. The protection of intellectual property rights shall be enforced in conformity with the laws, rules and regulations in force from time to time.

5.3. Each party may use the name, logo and/or official emblem of the other party for the purposes of this MoU subject to the prior written approval of the other Party.

5.4. Nothing contained herein shall authorize the Parties to use, apply or in any manner exploit or infringe the intellectual property rights of the other Party without prior written consent of such other Party, and the usage shall be in compliance with this MoU. In addition, the Parties undertake not to infringe the intellectual property rights of any third party.

5.5. Neither Party shall use (except as otherwise provided herein) or infringe on the other Party's intellectual property rights at any point of time. Both the Parties further undertake to help each other on a best effort basis in case of infringement by a third party of either Party's intellectual property rights.

5.6. None of the Parties shall use, register or attempt to register any of the Intellectual Property Rights which vests in the other Party, without the express permission of such Party. Any unauthorized attempt to use, register or attempt to register any of the Intellectual Property Right of a Party without express permission of such Party shall constitute an act of infringement of the Intellectual Property Rights of said Party under the relevant laws.

6. Amendment

Either Party may request in writing for a revision, modification or amendment of all or any part of this Memorandum of Understanding, and any revision, modification or amendment thus agreed to by the Parties shall be reduced in writing and shall form part of this Memorandum of Understanding.

7. Term and Termination

7.1. This Memorandum of Understanding shall come into force on the date of its signing by both the parties and shall remain in force for a period of One Year therefrom based on feedback received and continuing cordial relationship. It may further be extended by the parties as mutually decided based on the agreed terms and conditions reduced in writing.

7.2. Either party may also terminate this MoU by giving 60 days prior notice in writing to the other.

7.3. The parties are also of the understanding that the Clause No. 5 of the MoU shall remain valid and in force as per the law of the land even after the termination of the MoU.

8. General Clause

The ICAI and RGU will be organising four weeks residential programme at **RGU**, Guwahati titled as "Four

Weeks Residential Programme on Professional Skills Development” for the students of ICAI. The rights and obligations of RGU and ICAI and further details of the said programme will be as under:

- (i) One batch upto 50 participants will be conducted under this MoU on the dates as may be decided mutually by the parties. Every year the inflation will be considered for reviewing the MoU.
- (ii) RGU will be charging a fee of Rs. 1000/- per participant per day (inclusive of all taxes) from ICAI for each batch irrespective of batch size. Prior to and after the program if any participant leaves later/comes early, there will be a separate charge of Rs.1000/- per day.
- (iii) The bill of supply with GST Invoice (if applicable) for providing the required services will be raised by RGU within 30 days from the completion of the course as per mutually agreed terms and conditions between the parties. After submission of bill, payment to be made within 10-15 days by ICAI.
- (iv) The detailed contents of the programme and course methodology will be as may be decided by the ICAI.
- (v) At the end of each batch, each participant will be awarded a 'Certificate' of successful completion of the programme by the ICAI. It is the sole responsibility of ICAI to provide/not provide the certificates and RGU has no responsibility in this regard.
- (vi) The provisions of this MoU may be amended or modified at any time by supplementary MoUs in writing between the parties. The parties may also renew this MoU on Terms & Conditions mutually agreed.

9. Dispute Resolution

Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this Memorandum of Understanding shall be settled amicably through mutual consultation and/or negotiation between the Parties, without recourse to any third party or court.

10. Contacts

Each party hereby designates and appoints below its representative with overall responsibility for implementing this Memorandum. The Parties may, by written notice to the other Party, designate additional or different persons as points of contact but the Parties expect to have only one person at a time designated as the person with overall responsibility for all activities undertaken pursuant to this Memorandum.



- 5) ICT may recruit students from RGU for the internship program for a period of about 4 (four) weeks during summer and may be continued during the winter vacation depending upon the availability of the mentor faculty member from ICT.
- 6) Training and exchange of academic/administrative professionals in terms of academic/scientific fields by both institutions.
- 7) The issues related with the Intellectual Property Right (IPR) with regard to the outcome of the collaborative research and the outcome of thesis/projects work carried out under the joint supervision of the faculty from the partner institutes shall be governed through mutual agreement and within the framework of IPR policies of both the institutes.

Implementation

This MoU becomes effective from the date it is signed by the partner institutes and will be valid for an initial period of five years. The agreement may be extended by mutual consent. The MoU may have the provisions for modification to facilitate the requirements of the both the institutes from time to time. It may not be a legally binding document but may be intended to provide an outline/framework for the promotion of co-operation and collaboration



The Director of Indian Institute of Technology Guwahati (IITG) and the Vice-Chancellor / Director of The Assam Royal Global University (RGU) for the purpose of furthering cooperation in education and R&D activities between these two institutions, hereby affirm their intent to promote such academic collaborations and to participate in various academic endeavors.

2. OBJECTIVES:

This MoU envisages the fulfilling of the following objectives:

- (a) **IITG Faculty support to RGU:** IITG may permit its faculty to visit RGU for short durations ranging from one week to one year to teach at RGU, on mutually agreeable terms, for capacity enhancement at RGU;
- (b) **RGU Faculty support to IITG:** IITG may consider requests from RGU Faculty to visit IITG as 'Visiting' Faculty members, as per their designations, for research and teaching activities at IITG for limited durations, on mutual agreeable terms.
- (c) **Short-term Training Programmes:** Development and organization of short-term training and certificate courses by IITG and enabling RGU faculty / staff / students to take part in ongoing continuing education programmes and courses of IITG;
- (d) Enabling RGU faculty / students to pursue their Masters and Doctoral programmes at IITG on a full-time basis, as per existing IITG norms;
- (e) Cooperation from IITG for development of new areas of research and development at RGU;
- (f) **Guidance in infrastructure development:** Extension of technical cooperation in the form of knowhow from IITG for infrastructural development, management and upgradation of library and teaching / research laboratories facilities at RGU;
- (g) To jointly organize short term continuation programmes, seminars, conferences on topics of mutual interest and invite faculty members from both the institution to participate.

- (h) Each of the institutions will maintain their independent identity, logo symbol, image and make no other claims in their publicity material, media, websites, which is termed to be beyond the scope and nature of activities as incorporated in this memorandum. Each party will consult with and take approval of the other party to use the latter's name, the names of the latter's officials' / faculty members, and the logo for the activities under this MoU, and dissemination of results, on a case-by-case basis.
- (i) It is desirable that this MoU is not highlighted for the purpose of admission of students at RGU.

3. COORDINATORS:

The Director, IITG and the Vice-Chancellor / Director, RGU shall be primarily responsible for this cooperation at IITG and RGU, respectively. They may delegate their authority to coordinators whose responsibility will be to:

- (a) initiate action at their respective institutions to implement the provisions of this MoU.
- (b) coordinate and monitor the activities initiated under this MoU.
- (c) National regulations and customs shall be mutually respected.

4. GENERAL PROVISIONS:

- (a) This MoU shall have a duration of THREE years from the date of signature, unless either party gives a six-month notice of termination. This MoU may be extended further, in three-year increments, after review and by mutual written agreement.
- (b) This MoU is a non-binding expression of the current intentions of the Parties, and neither Party will incur nor be bound to any legal obligations or expenses hereunder to the other Party until and unless definitive agreements have been negotiated and approved by the management levels of each Party.

5. FINANCIAL OBLIGATIONS:

Incidental expenses, if any, with respect to the activities mentioned above will be met by RGU. Any expenditure w.r.t. visit of the IITG staff to RGU will be met by RGU. Other than that, there will be no financial obligations on both Parties under this agreement.

9. LEGAL RELATIONSHIP:





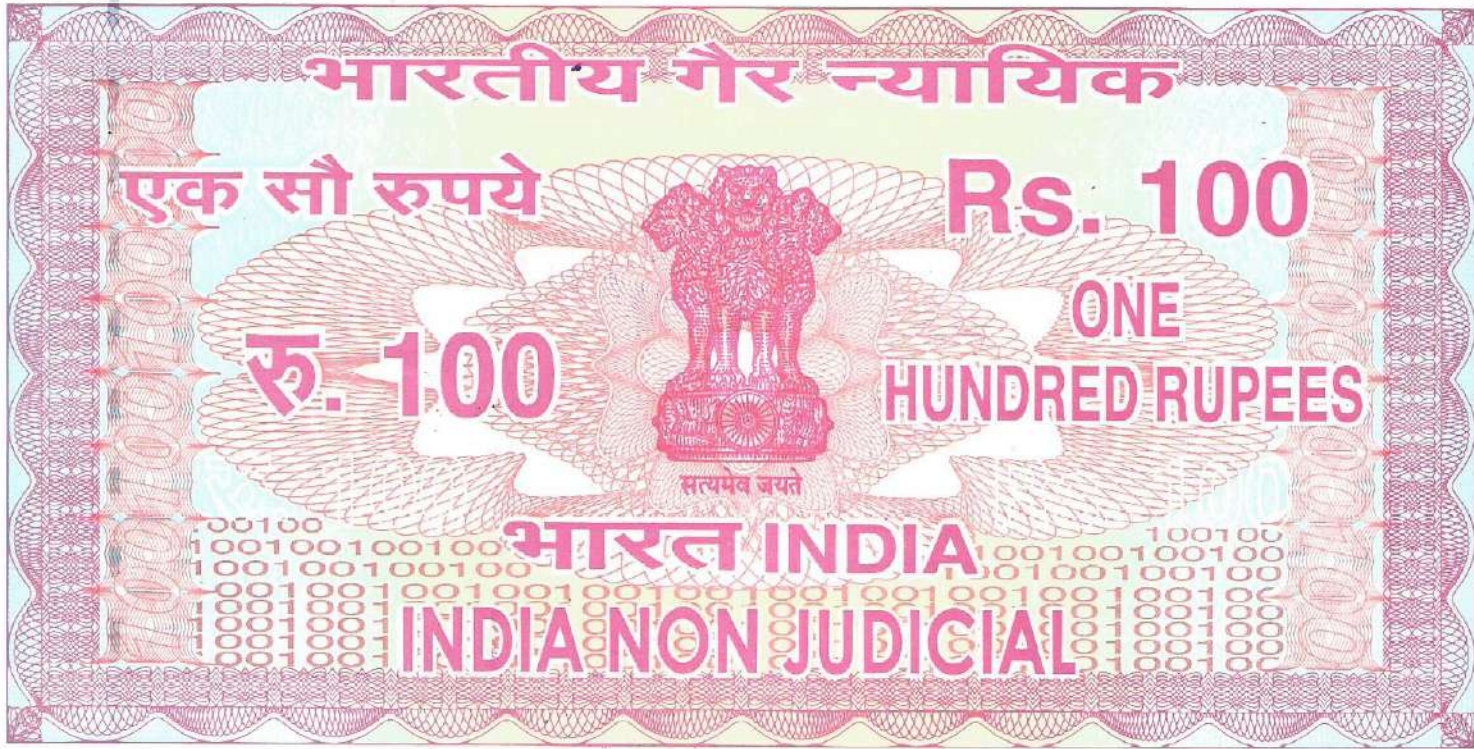

ARTICLE I: PURPOSE

- 2.1 Faculty members/scientists in both the institutions may teach in either institution with prior approval of their parent institutions;
- 2.2 Faculty members/scientists in both the institutions may collaborate and jointly supervise research scholars in either institution;
- 2.3 The facilities of one institution will in principle be available to faculty members/scientists and research scholars of the other institution. The detailed modalities to be worked out on a case to case basis;
- 2.4 Research scholars students of IASST may register for a Ph.D. at The Assam Royal Global University as per the Rules and Regulations of the University;
- 2.5 Courses offered by IASST may be recognized by RGU and appropriate credits assigned to a particular paper(s) after due evaluation by the University: Entrance examinations for research scholars may also be organized jointly or recognized by RGU if not done jointly after due scrutiny;
- 2.6 Both institutions shall endeavour to organise joint seminars, colloquium and other academic and outreach programs;



- 2.7 Both institutions shall endeavour to exchange relevant information in both academic and administrative matters;



ACADEMIC PROGRAMS TO BE DELIVERED

1. B. Com (H) in Finance & Accounts

AND whereas the First party with necessary support of SECOND PARTY is willing to deliver the above-mentioned programs at The Assam Royal Global University, Guwahati. BOTH PARTIES have agreed to enter a Memorandum of Understanding (MOU) in this respect and also have agreed to accept the following terms and conditions with a common intention of being legally bound by them.

The term First Party and the Second Party aforementioned unless repugnant to the context shall mean and include their successors in office, authorized representatives and assign etc.

Terms & Conditions

1. ROLES AND RESPONSIBILITIES OF THE FIRST PARTY

- 1.1 The First Party shall approve the syllabi of the above-mentioned programs developed by the Second Party in consultation with First party.
- 1.2 Shall be taking advice of the Second party in preparation of prospectus and admission forms. The first party will be responsible of selling the prospectus to prospective candidates and accepting filled in admission forms along with the prescribed fees and relevant documents. Both parties shall not charge any other fee, commit benefit / terms to the students apart from those stated in the prospectus/ fee structure.
- 1.3 The details of Syllabi, eligibility, program duration, and structure and assessment process of B. Com (H)-Finance & Accounts will be reviewed by both the parties as per the university norm and needs to be approved by the appropriate authorities of the University before commencement of the program.
- 1.4 Shall process applications so received and offer the admission as per rules and enrol such students and inform the Second Party in due course.
- 1.5 Shall share the fees received from the admitted students with the Second Party within 30days of starting the semester classes. The fee of the second semester and subsequent semesters are payable to ICA within 15 days after complete receipt of Semester fees from the students.
- 1.6 Shall issue identity card, Library Card, Registration certificate etc. to all admitted students as per University norms.
- 1.7 Shall provide required physical infrastructure such as classrooms, shared laboratory & staff room etc. for sales team and academic team with the appropriate furniture & fixtures, desktop, and internet facilities and any other facilities which may be required by the second Party for undertaking the course at the University campus. It has been agreed that University will provide one cabin/Counselling Desk at the main admission cell of the University for ICA for counselling and Admission process of this program.
- 1.8 Shall arrange to issue semester-wise and cumulative (final) mark grade cards and degree certificate to students as-per University norms.
- 1.9 The certificates /recognition to be conferred upon deserving students shall be conferred/awarded by the First Party. The award or withholding of any recognition shall be the sole discretion of First Party. Second Party shall have no right to decide on any issue or dispute relating to the grant or refusal of such awards/ certificates.

- 1.10 Shall ensure that the students enrolled for the said program are receiving the same hostel facilities and other benefits at par with the other students in the university, in a non-discriminating way.
- 1.11 Shall provide for the lodging facilities to the faculty teaching this program and to administrative staffs, if required as per availability and as per University norm.
- 1.12 Shall keep its website updated on information on the programs to be offered jointly with ICA Edu Skills Pvt Ltd from time to time. Expenses of hosting information in The Assam Royal Global University, Guwahati website shall be borne by First Party.
- 1.13 Shall provide second party with detailed operational guidelines (written/ printed) arising out of this MOU to be strictly followed.
- 1.14 Shall appoint/ depute a responsible person as coordinator to ensure proper functioning of the unit set up to conduct the programs covered under this MOU. The coordinator will also serve as one point contact for Second Party as far as working of the said association is concerned.
- 1.15 Faculty for this program to be recruited by Second Party on recommendation/in association of the First Party as per University norms or as decided by the Vice Chancellor of the University. The appointment letter/terms of appointment will be given by First Party. The salary/honorarium of the faculty will be mutually decided by both the parties and shall be paid by the First Party from the share of the Second Party. However, all faculty of this special program will be recruited as per policy of the University and any liability created out of this appointment will be of ICA Edu Skills Pvt. Ltd.
- 1.16 Shall ensure that no faculty or teaching staff or employee recruited for this specialized program would interchange to be a part of the Royal School of Commerce faculty team and vice versa without the prior permission of both the parties. –One NOC (No Objection Certificate) will be required from both the parties in case any faculty wishes to change either of the teams. Similarly, a cooling period of two years is to be maintained when any employee or staff or teaching faculty of the First Party is employed by the Second Party or Vice Versa.
- 1.17 The staff of this program shall not tamper with the course materials either by way of modification or restructuring. Any modification in course material & syllabi will be done on mutual agreement and after approval of competent authority of the University. The appointment under this agreement does not entitle First Party, to any right or interest over the intellectual Property of the Second Party and vice-versa. It shall be the responsibility of the First Party to ensure that none of its employees' agents or representatives causes any infringement to the rights of Second Party.
- 1.18 The first party & second party will mutually develop some course material (*If Required*) and will be registered copyright owners of such course materials. Second party will be exclusive copyright owner of any other material exclusively developed by them. The operation of this Agreement shall not operate to confer on First Party/Second Party, any right, title or interest over the said material. Any supplements and additional materials that may be supplied to First Party, the said course materials shall be given over to only the students who are duly registered and whose name and particulars have been sent to Second Party in accordance with this Agreement.

- 1.19 Shall be responsible for preparing teaching schedules of the course after discussion and agreement with the authorized person appointed by the Second Party.
- 1.20 Shall arrange to conduct the examinations by announcing the examination dates and schedule, preparing the question paper and evaluating the answer papers through faculty members of the program, arrange the requirements at the examination venues, and announce the results as per University norms.

2. ROLES AND RESPONSIBILITIES OF THE SECOND PARTY (ICA EDU SKILLS)

- 2.1. Shall ascertain for itself the financial viability of the programs B.Com(H)-Finance & Accounts to be launched under this MOU.
- 2.2 Shall ensure quality delivery of the course by qualified and trained faculty. ICA will be a part of the recruitment process of such quality faculty with relevant Industry and academics background. The selected faculty will be appointed by the First party and cost of salary etc. of such faculty will be borne by Second party.
- 2.3 Shall be solely responsible for the total cost of remuneration / payment and other allowances to the non-teaching staff selected by them.
- 2.4 Shall be responsible for providing appropriate student learning materials to students through the learning management system. Shall be responsible for providing the boarding and lodging facilities to the students during their Internship period(s) which are conducted outside University. The expenses with relation to this would be decided mutually & borne solely by the Second Party .
- 2.5 Shall be responsible for completion of both theory and practical training sessions of courses within the prescribed period for which the admissions have been made.
- 2.6 Shall provide all possible assistance to the First Party to conduct examinations.
- 2.7 Shall help faculty members of the program and coordinate for internal assessment of the students' and maintain appropriate record of the same. Such record will be made available to the First Party as and when demanded.
- 2.8 Shall be responsible for providing all promised active internships, placement assistance and guidance to the eligible/interested students enrolled under this program and will not charge any additional fee from the student for such internship. The students will bear boarding & lodging expenses on their own for such internships. The First Party does not hold any responsibility towards internships and final placement activities etc.
- 2.9 Shall keep its website continually updated regarding the courses offered under this MOU at The Assam Royal Global University, Guwahati Campus.
- 2.10 Shall provide a separate certificate of ICA along with award of University degree/certificate to the students completing the course.

3 SOME MUTUAL ROLES AND RESPONSIBILITIES

- 3.1 Project reports submitted by students as partial fulfilment of B.Com (H)-Finance & Accounts shall be the property of the Both the Parties.
- 3.2 First party and the second party agreed to have a joint meeting every quarter. A high powered steering committee to be formed comprising of the Head Sales, Head Academics (ICA Edu Skills) and Chief Mentor or Dean RSC & Head Admissions (RGU) to run this joint program successfully.

- 3.3 University ordinance/regulations/rules etc. with respect to attendance, examination, scholarship, award of degree etc, framed from time to time for other students of RGU shall be followed strictly for this program also.

4 ADVERTISING AND MARKETING

- 4.1 Second Party at its discretion may issue National & Local advertisements, carry out advertisement campaigns, Digital Campaign, leaflets, pamphlets, put up hoardings, banner, posters etc and/ or use electronic or print media to promote the collaborated Program.
- 4.2 All advertisements & publicity materials etc. shall be approved by both First and Second Party.
- 4.3 The program specific special prospectus of B.Com (H)-Finance & Accounts containing all relevant information, along with admission form shall be printed by the Second Party at their cost, after approval of the First party with regards to its content etc.

5 ADMISSION CYCLE

- 5.1. Admission Seats -There will be 120 seats in the First year Intake of B.Com (H)- Finance & Accounts Program. Intake may be increased in subsequent years by mutual agreement.
- 5.2. Student Transfer - Transfer of students either ICA B.Com (H) program to The Assam Royal Global University, Guwahati B.Com (H) program and vice-versa will only be allowed subject to mutual agreement between Head of Admissions ICA & Admissions Director Royal Global University and Dean, Royal School of Commerce. The Vice-Chancellor will be the final authority to approve the students transfer to either of the programs after commencement of the Orientation program. The Admission Director of RGU will have authority on the said issue if it is before the Orientation and during the Admission session.
- 5.3 Student Eligibility: The minimum eligibility to take admission in ICA programs will be mutually decided and will be as per the University norms.

6. EVALUATION


Examinations shall follow a semester evaluation system as per the norm laid down and approved by the competent authorities of the University.

The examination shall be conducted as per university norms. No examination fee will be charged from the students for semester end examinations, however examination fee w.r.t re-evaluation, re-check, back paper etc. will be as per University norms and there will be no share of Second Party in this fee.

6.2 External Semester End Exams-Weightage-70%-Will be done by Examination department of the University as per their Norms.

7. FEES STRUCTURE

- 7.1. The total fee per student per semester will be reviewed and prescribed jointly by The Assam Royal Global University, Guwahati, Assam & ICA EDU SKILLS.
- 7.2. Hence the fees revision can only be done at the start of the new academic year which shall be duly approved by competent authorities of the University.
- 7.3. The Cost of Hostel / transportation facilities which will be provided by The Assam Royal Global University, Guwahati to the students will be paid by students directly to The Assam Royal Global University, Guwahati. There will be no share of second Party in Hostel fees/ transportation fees.
- 7.4. Also, during the final year Internship (out of University campus) or any other internship that a student wish to choose, the student has to bear the Lodging and boarding cost at his own.
- 7.5. The total fee structure for B. Com-Finance & Accounts shall be framed by both parties. The fee will have various components, such as tuition fee, development fee, library fee, activity fee, examination fee etc.

8. SHARE OF FEE

- 8.1. The share of Tuition and other fee (development, library & activity) (Annexure-1) between the First party and Second Party would be in the ratio of 45:55 between the First Party and Second Party up to the annual intake of 120 students. If the annual intake cross 120 admissions, then the sharing will be 50:50 between both the parties. University Registration fee, re-registration fee, re-evaluation fee, back paper exam fee, security deposit etc. will come to First Party and will not be shared with Second Party.
- 8.2. First Party shall collect the full fees/ part fees from the students admitted. The Second Party shall be entitled to receive a sum equal to 55% (up to 120 annual intake) and 50% (120+ annual intake) of the total tuition fee received in respect of all the students who have been enrolled for the programs covered under this MOU after adjustment of all liabilities including salary/honorarium of faculty appointed exclusively for the referred program . The payment of GST, if any, is entirely the responsibility of the Second Party. The details of the course with Fees and respective sharing of both the parties is mentioned in Annexure - 1 attached to this agreement.
- 8.3. In case of withdrawal of admission, the refund of fees will be made as per the norm of the University with the appropriate adjustment between both the First and Second Party.
- 8.4. The number of admissions and the fee share in accordance will be considered final as per the count of students on the date of commencement of classes and subsequent withdrawals (if any) and refund (if any) will be adjusted appropriately between both the parties.

9. DURATION OF AGREEMENT

- 9.1. This Agreement shall remain valid and binding upon both the parties for a period of 5 years, effective from the date of commencement of the program. It may however be renewed if both parties are agreeable to the same. In the event of renewal, apart from signing of fresh agreement fresh financial term may be agreed to by mutual consent.
- 9.2. However, either party reserves the right to terminate this agreement in the event of other parties committing breach of any of its responsibilities mentioned above based on the findings of an Inquiry Committee constituted thereof. Till pending dispute settlement, this MOU will be operative.
- 9.3. If either of the two parties wishes to terminate the MoU from the forthcoming session, a written notice has to be submitted before 31st October of the preceding year by the party willing to terminate the association.
- 9.4. In case of termination of agreement and/or if either party decides against further renewal of this agreement, it shall be the responsibility of both The Assam Royal Global University, Guwahati and ICA EDU SKILLS to see that the students already studying (at the time of expiry/termination of this agreement) shall continue and complete the course as per provisions of this agreement and for this purposes the agreement shall be operative. Both the Parties will be responsible for every active student enrolled in this particular program to complete the course and in getting their certificate from the University.

10. JURISDICTION

In the event of any dispute or difference arising under this Agreement, the Parties shall try to discuss and arrive at an amicable resolution thereof. If the Parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed pursuant to the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The Parties agree that the decision of the arbitrator shall be final and binding on the Parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

In case of non-satisfaction of the decision of the arbitrator by both parties, the parties can move to the appropriate court having jurisdiction over it in Guwahati, Assam as the place of execution & operation of this MoU is Guwahati, Assam.

11. EXECUTION TERMS

The term of this Agreement shall commence from the date of signing of the document by both the parties for admissions for the forthcoming Academic year 2019-20.

12. AMENDMENT TO THE MOU

During the operation of the MOU, circumstances may arise which may call for alteration in the MOU, which shall be mutually discussed and agreed upon in writing and shall form the part and parcel of the original MOU.

Having gone through each and every condition of this Agreement and having understood it clearly and perfectly both the parties affix their signatures below as attesting to this deed on 21st January 2019.

This Memorandum of Understanding (MoU) is drawn up and agreed upon to establish the initial framework for cooperation between **Indian Institute of Management Indore** (hereinafter called IIM Indore) situated at Indore (Madhya Pradesh), India *and* **Royal Global University, Guwahati** (Hereinafter called RGU) situated at Guwahati (Assam), India.

This MOU is entered into on the *14th day of October, 2020* by and between

Indian Institute of Management Indore, established by the Department of Higher Education,
Ministry of Education, Government of India as Institutions of Excellence,

And

Royal Global University, Guwahati, a state private University established by The Assam Royal
Global University Act 2013, notified by the Government of Assam Gazette on 23/8/2013.

The aforesaid institutions are hereinafter referred to individually as *institute/university* and collectively as *institutes/universities*.

1: Scope

The initially proposed activities within the scope of the current MoU are:

- a) Activities leading to development of joint projects related to:
- Teachers training for RGU faculty,
 - Faculty & Staff Development Program for RGU faculties & staffs ,
 - Help RGU in building Short Term / Long Term Certificate Courses,
 - Working on collaborative research and consultancy projects,
 - To allow students of RGU for internship in IIM Indore (students selection will be based on certain parameters determined by selection committee, which is designed by RGU/IIM Indore),
 - To work together in various Corporate Social Responsibility (CSR) and Institutional Social Responsibility (ISR) accomplishment,

- b) Defining new areas of collaboration that have not been foreseen but can be beneficial to the Parties.

2: Duration, Termination and Amendment

- a) The MoU will be effective from the date of signing by both parties for a period of up to **three (3)** years and may be subject to extension by mutual consent of the Parties, expressed in writing.
- b) Either party may terminate this MoU by giving **one (1)** month's notice in writing to the other Party.
- c) The provisions of the MoU may be amended at any time with the mutual consent of the Parties in writing.
- d) The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination and expiration, unless otherwise agreed upon between the Parties.
- e) No action undertaken shall diminish the full autonomy of either institution, nor will either party impose any constraints upon the other in carrying out the agreement.

3: Special Provisions

- a) Each Party will consult with, and take approval of, the other Party to use the latter's name, the names of the latter's officials / faculty members, and logo for the activities under this MoU, and dissemination of results, on a case by case basis.
- b) Detailed modalities of individual forms of collaboration, activities associated with them and financial aspects of each shall be mutually agreed upon on a case by case basis, and specified, with all necessary details, in separate Agreements.
- c) This MoU will not be legally & financially binding to any of the Parties. The two Parties will consult with each other and attempt to resolve disputes or misunderstanding that arises in the administration of this MoU or any subsequent associated Agreement informally.

This Memorandum of Understanding (MoU) is executed on this
between Indian Institute of Technology Guwahati, North Guwahati, Assam – 781039, India – as
the First Part;

And

The Assam Royal Global University, Guwahati – as the Second part; herein together referred to
as “the Universities”.

Indian Institute of Technology Guwahati (IITG) is an autonomous body incorporated under the
Institute of Technology Act 1961, as amended up-to-date and established in 1994 having its
office at Guwahati, hereby represented by its Director. IIT Guwahati is the only academic
institute in India that occupied a place among the top 100 world universities, less than 50 years
of age, in world ranking. It is one of the most dynamic institutions in India, with one of the most
beautiful educational campuses in the country that provides an ideal setting for learning and
research. The institute is fully residential for the students, enriched with world-class facilities and
is empowered with a young dynamic faculty and staff.

And

The Assam Royal Global University, having its campus at Betkuchi, opposite Tirupati Balaji
Temple, NH 37, Guwahati, hereinafter referred to as ‘RGU’, is established by The Assam Royal
Global University Act, 2013, passed by Assam Legislative Assembly. The university is located
against the picturesque backdrop of Tirupati Balaji Temple on National Highway 37. It stands
high with its virtues of excellence and a humble contribution to the society at large. With
experienced faculty and world class infrastructure & facilities, The Assam Royal Global
University is one of the most promising universities of the country. It offers a unique educational
experience that prepares the next generation of global citizens to lead and make a difference in
the world. With its talented and motivated student-body and accomplished faculty, The Assam
Royal Global University is a leading educational hub in the North Eastern region that maintains a
particular commitment to exceptional undergraduate and post-graduate instructions, and aims to
be the best University of the region.

Whereas RGU has requested IITG to **mentor** the upcoming University to achieve its objectives,
through various programmes for the academic promotion and administrative guidance with the
following identified but not limited to,

1. **IITG Faculty support to RGU** – Faculty members of IITG may take some classes or a
series of lectures at RGU as resource persons for portions or special topics of a few
identified courses in consultation with the faculty members of RGU at a mutually
convenient timing. The IITG faculty, agreeing to take classes at RGU, shall be provided
with transport and an honorarium as per RGU norms.

2. **Final Year Projects of RGU Students** – IITG may consider a few selected final year students of RGU, on mutual consultation between the faculty members of these two institutes, to do their project/thesis work at IITG subject to availability of lab, consumables and other infrastructural facilities. Prior approval from the Head of the concerned department is necessary for each such student.
3. **Joint Submission of Collaborative Projects** – IITG and RGU faculty members may submit joint project proposals for funding from different funding agencies.
4. **Joint organization of Seminars / Symposia / Workshop** – Seminars / Workshops / Symposia may be jointly organized by IITG and RGU.
5. **Summer and Winter Training/Internship** – IITG may recruit students from RGU for the internship programme for a period of about 4(four) weeks during summer and may be continued during the winter vacation depending upon the availability of the mentor faculty member from IITG.
6. **Facilitate visitors of IITG to visit RGU** – IITG may facilitate the visitors / guests coming to IITG to visit RGU depending on their travel schedule.
7. **Guidance in University Administration** – RGU is an upcoming University and a beginner in many aspects. IITG may provide guidance to RGU staff in areas like administration, admissions, recruitment of staff and organizing convocation etc. with approval from/consultation by the Registrar, IIT Guwahati.
8. **Guidance in infrastructure development** – IITG may provide guidance to RGU in upgrading of University infrastructure like laboratories, equipment, library, class rooms, recreational facilities, hostels, campus maintenance by providing necessary specifications and operational guidance wherever required. Such jobs will require permission and/or consultation by the Dean Infrastructure Planning and Management (DoIPM), IITG. DoIPM may obtain necessary technical guidance from different departments/sections of IITG for upgradation of Labs, equipment, library etc.
9. **Sports promotion** – IITG and RGU may conduct some Inter-University friendly matches in selected sports on mutual consultation. Prior approval of the Dean of Students' Affairs (DoSA)/Sports Board of IITG is needed.
10. This is a non-binding MoU and there shall be no financial obligation on IIT Guwahati as a partner in this MoU.

Both IITG and RGU agree that any information which is exchanged pursuant to this Memorandum of Understanding will be kept strictly confidential and used solely for the purpose, covered by this Memorandum of Understanding, unless such information was obtained by a third party who does not have an obligation of confidentiality toward the information-disclosing party and entered public domain. It is desirable that this MoU is not highlighted for the purpose of admission of students at RGU.

Incidental expenses, if any, with respect to the activities mentioned above will be met by RGU. Any expenditure with respect to visit of the IITG staff to RGU will be met by RGU.

Subject to clauses below, both the Universities may amend this Memorandum of Understanding by mutual consent in writing. Any amendment agreed by the Universities shall come into effect from the date determined by the signing Universities on potential areas.

This Memorandum of Understanding shall enter into force on the date of signing and shall initially be valid for a period of three years. Thereafter, the institutions, that is IITG and RGU shall agree on mutual consent on the continued validity of this Memorandum of Understanding. However, IITG has freedom to continue or discontinue the MoU at its own discretion.

The institutions, that is IITG and RGU, agree that this Memorandum of Understanding shall enter into force on the basis of goodwill and shall not be legally bound. Nothing mentioned in this Memorandum of Understanding shall deem constitute partnership between the signing Universities appointing one party as an agent of the other. This Memorandum of Understanding will be effective upon signature by both the Chief Executive Officers for a period of three years, at which time it will be reviewed for possible renewal for further three-year period. Either party may, on three (03) month notice in writing, terminate the MoU in advance of its normal expiration or request the recognition of its conditions.

National Institute of Pharmaceutical Education and Research (NIPER-G) and **The Assam Royal Global University**, hereinafter collectively referred to as 'the Parties' and individually as 'the Party'.

2.0 Purpose:

Desiring to promote co-operation in academic education and research.

HAVE REACHED the following understanding:

Article 1: Forms of Cooperation

The Parties envisage the following cooperation within the scope of this Memorandum of Understanding (MoU):

Article 1.1: Exchange of Faculty members

For planning and handling of academic programs and courses, organization of seminars, workshops and conferences including the exchange of mutual experiences in teaching, research and industrial practice.

Article 1.2: Exchange in Research

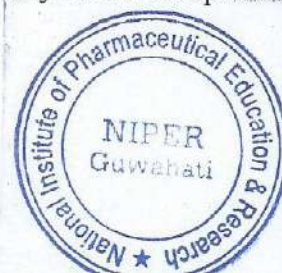
Through Joint programs in research and development, including provision of summer/winter Internship Programme for the students of The Assam Royal Global University with an internship charge as per the NIPER Guwahati norms.

Article 1.3: Twin Programs

Explore possibilities of joint twining programs in interdisciplinary areas of specialization of high relevance to both Parties.

Article 1.4: Others

To jointly organize short-term continuing education programmes, to organize seminars, conferences, or workshops on topics of mutual interest, and invite faculty members from both the institutions to participate therein.

Article 2: Specific Co-Operation Projects

Specific co-operation projects shall be negotiated separately between the Parties and in each specific case shall be established as separate written agreements, stating the respective rights and obligations of the Parties. Such an agreement for collaboration or exchange programmes will be legitimised by the completion of a specific MoU. In case of any ambiguity or disagreement between the terms and conditions of this MoU and those of the separate agreement as mentioned above, the terms and conditions of such separate agreement shall prevail over the terms of this MOU.

Article 3: Financial Obligations

There will be no financial obligations on both the Parties under this agreement.

Article 4: General Coordinators

Each Party shall designate an administrative office to oversee, and facilitate the implementation of any agreements arising out of this MoU. National regulations and customs shall be mutually respected.

Article 5: Intellectual Property Rights

NIPER-G and RGU agree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions and patents generated during the MoU, shall remain the common intellectual property of the Parties. The Parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.

Article 6: Dispute Settlement

Any dispute, controversy, or claim arising out of or in relation to this MoU, including the validity, invalidity, breach or termination thereof, shall be settled by the parties amicably through mutual consultations and negotiations.

Article 7: Liability

Except for loss or damages caused through gross negligence or intent, the Parties shall have no liability to each other hereunder.

Article 8: Legal Relationship

This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the Parties. Nothing in this MoU shall be construed to create any legal relationship between the Parties.

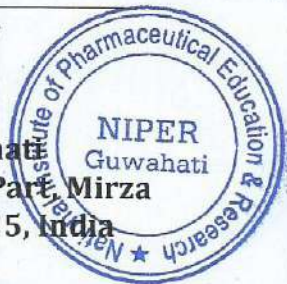



MEMORANDUM OF UNDERSTANDING

National Law University and Judicial Academy, Assam (NLUJAA) was established by the National Law University and Judicial Academy, Assam Act, 2009 (Act No. XXV of 2009 as the fourteenth National Law University established in the country and is located in Guwahati, the capital city of Assam. Hon'ble, the Chief Justice of Gauhati High Court is the Chancellor of the University. The objectives of the National Law University and Judicial Academy, Assam are "to impart comprehensive legal education and training at all levels to achieve excellence in legal education; to promote research in all branches of law; to disseminate legal knowledge by organizing lectures, seminars, symposia, workshops and conferences on contemporary issues of law to promote legal awareness in the communities to achieve social and economic justice and to promote cultural, legal and ethical values with a view to promote and foster the rule of law and the objectives enshrined in the Constitution of India; and to liaise with institutions of higher learning and research in India and abroad". National Law University and Judicial Academy, Assam offers B.A.LL.B.(Hons.) Five-Years Integrated Programme, LL.M. One Year Programme and Ph.D. Programme. Various Diploma, Certificate and Degree courses through distance mode and online being offered by various Centres established in the University for advanced legal studies and research. The Centres shall also address the socio-legal issues and challenges specifically of the North-East region. Some of the Centres have been conducting seminars, conferences, and training programmes for the identified target groups. The University has affiliation with the UGC under Section 2(f) of the University Grants Commission Act, 1956, the Bar Council of India (BCI) and the Association of Indian Universities (AIU). The University has initiated the process of its accreditation by the National Assessment and Accreditation Council (NAAC).

The Campus is more than 27 acres of land and about 12 lakh square feet built up centrally air-conditioned area available for running various courses of Royal Global University (RGU). With experienced faculty and world class infrastructure & facilities, Royal Global University is one of the finest Universities of the country. RGU offers a unique educational experience that prepares the next generation of global citizens to lead and make a difference in the world. With its talented and motivated student-body and accomplished faculty, RGU is a leading educational

hub in the North Eastern region that maintains a particular commitment to exceptional undergraduate and postgraduate instructions. Undergraduates, Graduates and post graduates will have variety of options available to them. The faculty members work closely with students to solve major scientific, technological and societal challenges. RGU ensures that its students are transformed into well-rounded, industry-ready individuals, who are equipped to take on leadership responsibilities. RGU stands to be recognized for its world-class infrastructure, cultural events, campus recruitment programmes and activities, expert students, and updated facilities.

SCOPE OF AGREEMENT

This Memorandum of Understanding is signed between the National Law University and Judicial Academy, Assam as First Party and The Assam Royal Global University, Guwahati as Second Party for the purpose of Academic Collaboration that will encompass exchange of students and members of faculty between the two parties and initiate other academic activities, research and publication. In addition to this, active efforts will be made to develop joint training and research programmes that will be pursued in a collaborative spirit. Some of the collaborative areas include the following:

I. TERMS AND CONDITIONS OF COOPERATION

1. NLUJAA and RGU shall collaborate in mutually agreeable academic events, teaching, training and research, wherever feasible. Such collaboration will be based on mutually agreeable terms and conditions specifically agreed for each of the collaborative efforts;
2. NLUJAA and RGU shall offer full time regular as well as optional courses to the undergraduate and postgraduate degree courses offered at these institutions from time to time on mutually agreeable terms and conditions;
3. The Ph.D. candidates in interdisciplinary areas of research involving law from the RGU may work under the supervision of the faculty members of NLUJAA or if agreed, jointly supervised by the faculty members from the two parties;
4. Faculty members from each of these universities shall be invited for important seminars, conferences, workshops, capacity building programmes and for teaching at undergraduate, postgraduate and doctoral levels. The financial implications shall be worked out on a case to case basis;

5. Those modalities for a similar exchange of Researcher Scholars and Faculty Members will be laid down through mutual discussion that should be made operational for a period of five years;
6. Ph.D. Scholars of both the universities are welcome to access the library resources of each other and to have academic interaction with the faculty;
7. Research Scholars and Teaching Faculty of both NLUJAA and RGU, will explore possibility of taking up collaborative research work and also apply for funding from national and international agencies, government, non-government organizations and other funding agencies; and
8. Any financial implication emerging out of such collaborations (other than the fee of the students etc.) shall be worked out and decisions will be taken with mutual agreement.

II. AREAS OF COOPERATION

This Memorandum expresses a mutual desire by NLUJAA and RGU to cooperate in building intellectual and research capacity and scholarship. Additional areas of co-operation may be added by written consent of the two parties. Both the parties will act in good faith to ensure that the objectives of this Memorandum are realized.

III. TERMS OF AGREEMENT

Progress in realizing the terms and conditions referred herein will be reviewed periodically as mutually agreed and the memorandum may be amended at any time by mutual consent and in writing. The implementation and / or continuance of programmes or projects established pursuant to this memorandum prior to the effective date of termination shall not be affected by the termination of this Memorandum.

1. This memorandum shall come into force immediately upon its signature by the parties;
2. The validity of this Memorandum of Understanding is initially for a period of five years from the date of its execution and the same can be further extended on mutual agreement; and
3. This Memorandum of Understanding can be terminated by either of the parties by giving advance notice of six months and without jeopardizing the coursework or registration of any of the students or scholar of either institution.

IV. INTELLECTUAL PROPERTY AND CONFIDENTIALITY


1. In respect of each project and programme of co-operation, the parties shall negotiate and mutually agree in writing on their respective rights to intellectual property and commercial exploitation of the same (including without limitation, trademarks and service marks, copyrights, patents, designs and confidential information pertaining thereto); and
2. Neither party shall, at any time disclose to any third party any confidential information of the other party which is acquired in the course of activities under this Memorandum, a collaborative project or a programme, without the prior consent of the other party in writing.

The confidentiality obligations herein will not apply to information in the public domain; information in the possession of the receiving party prior to the disclosure of the information; information which is independently developed by the receiving party; information required to be released by law; and information which is rightfully received by the receiving party from third parties without any breach of confidentiality obligations.

V. NON BINDING NATURE OF MEMORANDUM


Nothing in this Memorandum shall be construed as creating any contract, partnership, agency or other legal relationship between the parties. This Memorandum is only a non-binding statement of intent to foster genuine and mutually beneficial collaboration.
